## **ERRATA**

### **Point allocation table- Experience and track record.**

Page 15 of 59 – In the table which sets out the test for the Technical and Functional threshold, Transnet requires that the bidder must provide three (3) contactable references with relevant supporting reference letters for **each** of PSP Transaction Advisory **and** PSP Legal Transaction Advisory / Mergers & Acquisitions work done in the selected legal practice areas or category. However, for both the *"Relevant experience and track record of similar projects undertaken for the category of PSP transaction advisor services"* and for the *"Relevant experience and track record of similar projects undertaken for the category of PSP legal transaction advisory services or Merger and Acquisition"* the points for each fully compliant reference letter has been erroneously stated as **"15 points"** instead of **5 points**.

Relevant experience and track record of similar projects undertaken for the category of PSP transaction advisor services (Total 15 points):

**Current incorrect wording:** *"15 points for each relevant reference letter that is fully compliant and meets minimum thresholds."*

**Correct wording:** *"5 points for each relevant reference letter that is fully compliant and meets minimum thresholds."*

Relevant experience and track record of similar projects undertaken for the category of PSP legal transaction advisory services or Merger and Acquisition

**Current incorrect wording:** *"15 points for each relevant reference letter that is fully compliant and meets minimum thresholds."*

**Correct wording:** *"5 points for each relevant reference letter that is fully compliant and meets minimum thresholds."*

**Except as amended above, the scoring guideline remains unchanged.**
