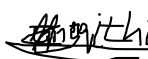

Work time (knock on time, tea time, lunch time and knock off time). 2.Toolbox/safety talks. 3.PPE. 4. Contingency plan (e.g. Plan around public transport strike, sick/absent staff members). 5. Chemicals (weed killer). 6. Cutting grass and trees along railway lines and boundary fences. 7. 1.5m clearance from infrastructure. 8. Cutting 20m high, 4m (horizontal length) trees to 2m height. 9. Removal of rubbish from Transnet Engineering site. 10. Using net to prevent stones from damaging cars in the vicinity. 11. Assurance of quality of work, supervision of work. 12.Plan on working during December and January months. 13.Submission of payment claims / Invoices. 14. 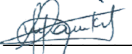
