2. Stage Two - Functionality

Only those tenderers who obtain the minimum qualifying score for functionality will be evaluated further in terms of price and the applicable preference point system. The minimum qualifying for score for functionality is **60 points**.

6 TRANSNET'S LIST OF EXCLUDED TENDERERS (BLACKLIST)

- 6.1 The process of restriction is used to exclude a company/person from conducting future business with Transnet and other organs of state for a specified period. No Tender shall be awarded to a Tenderer whose name (or any of its members, directors, partners or trustees) appear on the Register of Tender Defaulters kept by National Treasury, or who have been placed on National Treasury's List of Restricted Suppliers. Transnet reserves the right to withdraw an award, or cancel a contract concluded with a Tenderer should it be established, at any time, that a tenderer has been restricted with National Treasury by another government institution.

- 6.2 All the stipulations on Transnet's restriction process as laid down in Transnet's Supply Chain Policy and Procurement Procedures Manual (CPM included) are included herein by way of reference. Below follows a condensed summary of this restriction procedure.
- 6.3 On completion of the restriction procedure, Transnet will submit the restricted entity's details (including the identity number of the individuals and registration number of the entity) to National Treasury for placement on National Treasury's Database of Restricted Suppliers for the specified period of exclusion. National Treasury will make the final decision on whether to restrict an entity from doing business with any organ of state for a period not exceeding 10 years and place the entity concerned on the Database of Restricted Suppliers published on its official website.
- 6.4 The decision to restrict is based on one of the grounds for restriction. The standard of proof to commence the restriction process is whether a "*prima facie*" (i.e. on the face of it) case has been established.
- 6.5 Depending on the seriousness of the misconduct and the strategic importance of the Goods/Services, in addition to restricting a company/person from future business, Transnet may decide to terminate some or all existing contracts with the company/person as well.
- 6.6 A Service Provider or Contractor to Transnet may not subcontract any portion of the contract to a blacklisted company.
- 6.7 Grounds for blacklisting include: If any person/Enterprise which has submitted a Tender, concluded a contract, or, in the capacity of agent or subcontractor, has been associated with such Tender or contract:
 - a) Has, in bad faith, withdrawn such Tender after the advertised closing date and time for the receipt of Tenders;
 - b) has, after being notified of the acceptance of his Tender, failed or refused to sign a contract when called upon to do so in terms of any condition forming part of the Tender documents;
 - c) has carried out any contract resulting from such Tender in an unsatisfactory manner or has breached any condition of the contract;
 - d) has offered, promised or given a bribe in relation to the obtaining or execution of the contract;

- e) has acted in a fraudulent or improper manner or in bad faith towards Transnet or any Government Department or towards any public body, Enterprise or person;
 - f) has made any incorrect statement in a certificate or other communication with regard to the Local Content of his Goods or his B-BBEE status and is unable to prove to the satisfaction of Transnet that:
 - (i) he made the statement in good faith honestly believing it to be correct; and
 - (ii) before making such statement he took all reasonable steps to satisfy himself of its correctness;
 - g) caused Transnet damage, or to incur costs in order to meet the contractor's requirements and which could not be recovered from the contractor;
 - h) has litigated against Transnet in bad faith.
- 6.8 Grounds for blacklisting include a company/person recorded as being a company or person prohibited from doing business with the public sector on National Treasury's database of Restricted Service Providers or Register of Tender Defaulters.
- 6.9 Companies associated with the person/s guilty of misconduct (i.e. entities owned, controlled or managed by such persons), any companies subsequently formed by the person(s) guilty of the misconduct and/or an existing company where such person(s) acquires a controlling stake may be considered for blacklisting. The decision to extend the blacklist to associated companies will be at the sole discretion of Transnet.

7 PREVIOUS TRANSGRESSIONS

- 7.1 The Tenderer/Service Provider/Contractor hereby declares that no previous transgressions resulting in a serious breach of any law, including but not limited to, corruption, fraud, theft, extortion and contraventions of the Competition Act 89 of 1998, which occurred in the last 5 (five) years with any other public sector undertaking, government department or private sector company that could justify its exclusion from its registration on the Tenderer's/Service Provider's/Contractor's database or any tendering process.

- 7.2 If it is found to be that the Tenderer/Service Provider/Contractor made an incorrect statement on this subject, the Tenderer/Service Provider/Contractor can be rejected from the registration process or removed from the Tenderer/Service Provider/Contractor database, if already registered, for such reason (refer to the Breach of Law Returnable Form contained in the document.)

8 SANCTIONS FOR VIOLATIONS

- 8.1 Transnet shall also take all or any one of the following actions, wherever required to:
- a) Immediately exclude the Tenderer/Service Provider/Contractor from the tendering process or call off the pre-contract negotiations without giving any compensation to the Tenderer/Service Provider/Contractor. However, the proceedings with the other Tenderer/Service Provider/Contractor may continue;
 - b) Immediately cancel the contract, if already awarded or signed, without giving any compensation to the Tenderer/Service Provider/Contractor;
 - c) Recover all sums already paid by Transnet;
 - d) Encash the advance bank guarantee and performance bond or warranty bond, if furnished by the Tenderer/Service Provider/Contractor, in order to recover the payments, already made by Transnet, along with interest;
 - e) Cancel all or any other contracts with the Tenderer/Service Provider/Contractor; and
 - f) Exclude the Tenderer/Service Provider/Contractor from entering into any Tender with Transnet in future.

9 CONFLICTS OF INTEREST

- 9.1 A conflict of interest includes, inter alia, a situation in which:
- a) A Transnet employee has a personal financial interest in a tendering / supplying entity; and
 - b) A Transnet employee has private interests or personal considerations or has an affiliation or a relationship which affects, or may affect, or may be perceived to affect his / her judgment in action in the best interest of Transnet, or could affect the employee's motivations for acting in a particular manner, or which could result in, or be perceived as favouritism or nepotism.
- 9.2 A Transnet employee uses his / her position, or privileges or information obtained while acting in the capacity as an employee for:
- a) Private gain or advancement; or

- b) The expectation of private gain, or advancement, or any other advantage accruing to the employee must be declared in a prescribed form.

Thus, conflicts of interest of any Tender committee member or any person involved in the sourcing process must be declared in a prescribed form.

- 9.3 If a Tenderer/Service Provider/Contractor has or becomes aware of a conflict of interest i.e. a family, business and / or social relationship between its owner(s)/ member(s)/director(s)/partner(s)/shareholder(s) and a Transnet employee/ member of Transnet's Board of Directors in respect of a Tender which will be considered for the Tender process, the Tenderer/Service Provider/ Contractor:

- a) must disclose the interest and its general nature, in the Request for Proposal ("RFX") declaration form; or
- b) must notify Transnet immediately in writing once the circumstances has arisen.

- 9.4 The Tenderer/Service Provider/Contractor shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any committee member or any person involved in the sourcing process, where this is done, Transnet shall be entitled forthwith to rescind the contract and all other contracts with the Tenderer/Service Provider/Contractor.

10 DISPUTE RESOLUTION

- 10.1 Transnet recognises that trust and good faith are pivotal to its relationship with its Tenderer / Service Provider / Contractor. When a dispute arises between Transnet and its Tenderer / Service Provider / Contractor, the parties should use their best endeavours to resolve the dispute in an amicable manner, whenever possible. Litigation in bad faith negates the principles of trust and good faith on which commercial relationships are based. Accordingly, following a blacklisting process as mentioned in paragraph 6 above, Transnet will not do business with a company that litigates against it in bad faith or is involved in any action that reflects bad faith on its part. Litigation in bad faith includes, but is not limited to the following instances:

- a) **Vexatious proceedings:** these are frivolous proceedings which have been instituted without proper grounds;
- b) **Perjury:** where a Tenderer / Service Provider / Contractor make a false statement either in giving evidence or on an affidavit;
- c) **Scurrilous allegations:** where a Tenderer / Service Provider / Contractor makes allegations regarding a senior Transnet employee which are without proper foundation, scandalous, abusive or defamatory; and

- d) **Abuse of court process:** when a Tenderer / Service Provider / Contractor abuses the court process in order to gain a competitive advantage during a Tender process.

11 GENERAL

- 11.1 This Integrity Pact is governed by and interpreted in accordance with the laws of the Republic of South Africa.
- 11.2 The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the law relating to any civil or criminal proceedings.
- 11.3 The validity of this Integrity Pact shall cover all the tendering processes and will be valid for an indefinite period unless cancelled by either Party.
- 11.4 Should one or several provisions of this Integrity Pact turn out to be invalid the remainder of this Integrity Pact remains valid.
- 11.5 Should a Tenderer/Service Provider/Contractor be confronted with dishonest, fraudulent or corruptive behaviour of one or more Transnet employees, Transnet expects its Tenderer/Service Provider/Contractor to report this behaviour directly to a senior Transnet official/employee or alternatively by using Transnet's "Tip-Off Anonymous" hotline number 0800 003 056, whereby your confidentiality is guaranteed.

The Parties hereby declare that each of them has read and understood the clauses of this Integrity Pact and shall abide by it. To the best of the Parties' knowledge and belief, the information provided in this Integrity Pact is true and correct.

C3.1 EMPLOYEES WORKS INFORMATION

1 DESCRIPTION OF THE SERVICE

1.1 Executive Overview

Transnet Port Terminals is a division of Transnet SOC Limited whose core business is to provide cargo handling to a wide spectrum of customers, including shipping lines, freight forwarders and cargo owners. Operations are divided into four major business segments, namely containers, bulk, break bulk and automotive. The Dry Bulk Terminal (DBT) comprises of conveyor belts, ship loaders, ship unloaders, stackers and conveyor belt systems infrastructure for import, export and stacking of bulk commodities like coal, chloride, magnetite, and sulphur to list a few. Multi-Purpose Terminal (MPT) handles a mixture of commodities with the use of road truck transport, skips, forklifts, mobile ship loader cranes, ship unloader mobile cranes, straddlers and many more.

To achieve the required handling rates the terminals are required to operate on a 24hr/7 basis therefor handling equipment must be maintained and repaired. The supply of comprehensive scaffolding services is required to ensure safety when maintenance or repairs are taking place at elevated positions where there is no safe access for technical personnel to perform required task(s).

1.2 Employers Objective

The Employer's objective is to ensure that a service provider be appointed to provide reliable, comprehensive, and cost-effective scaffolding erection and certification service for a period of 5 years to TPT, Richards Bay Terminals on an as and when required basis.

1.3 Main Works Information

A *service provider* is required to provide the following services at Richards Bay, Transnet Port Terminals:

- 1.3.1 Scaffolding services for all breakdowns and planned work.
- 1.3.2 Scaffolding specific safety requirements.
- 1.3.3 Tagging Systems
- 1.3.4 Equipment and tools requirement.

2 SERVICE INFORMATION

2.1 Scaffolding services for all breakdowns and planned work

- 2.1.1 The service provider is required to supply, erect, modify and dismantle scaffolding as and when instructed by a TPT representative.
- 2.1.2 The service provider must supply quick stage (pin lock) scaffold material to be able to complete the required number of towers. This must include cantilevers, ladder beams and manually controlled hanging platforms.
- 2.1.3 All scaffolding supplied must comprise of steel toe-boards and steel platforms.
- 2.1.4 The service provider must have at least 10-ton scaffolding material to be made available for TPT on an as and when required basis.
- 2.1.5 The scaffolding crew is required to report on site within **60 mins** of receiving a call-out from a TPT RCB technical representative.
- 2.1.6 The service provider is required to have 3 scaffolding crews ready to service TPT RCB on an as and when required basis for breakdowns and planned work.
- 2.1.7 Each scaffolding crew shall consist of the below as a minimum:
 - 2.1.7.1 1 x Scaffolding Inspector
 - 2.1.7.2 1 x charge hand
 - 2.1.7.3 1 x fixer
 - 2.1.7.4 2 x scaffolders
- 2.1.8 The service provider is required to have one (1) supervisor to supervise the three (3) crews mentioned above in section 2.1.2.
- 2.1.9 The service provider is required to have CETA registered and SAQA authorized certification for each team member in line with applicable laws and standards for safe erection, use and dismantling of scaffolding.
- 2.1.10 The service provider is required to have three (3) radio communications for each crew.
- 2.1.11 The Service provider is required to ensure that enough transportation and resources are available to fulfil TPT's requirement from time to time. The minimum transport requirements are:
 - 2.1.11.1 2 x suitable trailers
 - 2.1.11.2 1 x 1-ton bakkies (including fuel)
 - 2.1.11.3 1 x 7-ton truck and driver (including fuel)

2.2 Scaffolding Specific Safety Requirements

- 2.2.1 The scaffolding must be erected, modified, dismantled by qualified and certified personnel.
- 2.2.1 All scaffolding erected must comply with the requirements of SANS 10085-1:2004 (The design, erect, use and inspection of access scaffolding).
- 2.2.2 A competent/certified person must be appointed to supervise the erection, dismantling or altering of any scaffold and he must inspect each scaffold before use, once every week and after inclement weather and record the findings in the appropriate register.
- 2.2.3 All defective scaffold material must be replaced immediately.
- 2.2.4 Any scaffold structure must be braced or secured to prevent movement in any direction.
- 2.2.5 Safety harness must be worn by all persons working on a platform of more than 1.83m from the ground.
- 2.2.6 Platforms must always be kept free from any obstruction and must be kept in a non-slip state.
- 2.2.7 Scaffolding must be provided with safe and convenient access consisting of the following:
 - 2.2.7.1 Platforms up to 5m above ground, vertical ladders may be used provided they are secured to the scaffold structure and protrude at least 1 m above the platform.
 - 2.2.7.2 Platforms over 5m above ground included ladders must be used, provided:
 - 2.2.7.2.1 Ladders are not longer than 3m.
 - 2.2.7.2.2 Ladders are secured to the scaffold structure.
 - 2.2.7.2.3 Access to the ladders is gained by substantial landings which are provided with toe-boards.
 - 2.2.7.2.4 Landings are sufficiently large to be used as a rest station for persons climbing the scaffold.
- 2.2.8 Pulley-blocks, sheaves, winches or hoists of the suspended scaffolding must be of the correct size for the ropes being used and at least four independent steel ropes must be used.
- 2.2.9 Steel wire ropes must have a safety factor of ten in respect of the maximum load which each rope must carry and the machinery used for lifting or lowering the platform must be fitted with a safety device to prevent any uncontrolled movement.

- 2.2.10 Machinery used for lifting or lowering must be easily accessible for inspection and must be on a planned maintenance system with the inspection register kept up to date.
- 2.2.11 Machinery, including pulley blocks, sheaves, etc., must be completely guarded and the rope connections must be vertically above the connections to the work platform.
- 2.2.12 Out riggers must be constructed of steel with a safety factor of 4 with respect to the load it is to carry.
- 2.2.13 Out riggers must be suitably spaced and must not be anchored by means of weights at the inner end.
- 2.2.14 Out riggers must not have an overhang of more than 1.8m beyond the edge of the structure and must be of such length that the counteracting length can be anchored securely.
- 2.2.15 Out riggers must be provided with a stop or an effective device at the outer ends to prevent displacement of the ropes.
- 2.2.16 Working platforms must be at least 456mm but not more than 1800mm wide and must be suspended as near to the structure as possible at every working position to prevent horizontal movement between the working platform and the structure.
- 2.2.17 Working platforms must have substantial guardrails of at least 900mm but not more than 1000mm in height and must be fitted with toe-boards of at least 150mm high with no open space between the toe-boards and guard-rails.
- 2.2.18 The height of mobile scaffolding should not be more than three (3) times the smallest dimension of the base.
- 2.2.19 The minimum base of mobile scaffolding width must be 1.295m.
- 2.2.20 Mobile scaffolding must have an effective locking system.

2.3 Tagging systems

- 2.3.1 Once erected, inspected and approved for use, a green "Safe to use" tag must be placed at the access point, the reverse side of the tag must be signed and include the date and scaffold number.
- 2.3.2 The scaffold supervisor must inspect scaffold at least once a week and after inclement weather. Findings of the inspection must be entered in the register. The green tag must have the inspection date updated if the scaffold is still safe for use.
- 2.3.3 If, at any time a scaffold is found to be unsafe by scaffolding supervisor for use, the green tag must be replaced with a red tag and the work on the scaffold is to cease at once and the danger tape must be used as an indication of unsafe scaffolding.
- 2.3.4 Only when the unsafe condition has been rectified may work continue.

2.4 Scaffolding equipment and tools requirements

4 PARTIES RESPONSIBILITIES

4.1 Contractor's Responsibilities

- 4.1.1 Affected Property entry and security control, permits, and Affected Property regulations
 - 4.1.1.1 The *Contractor* complies with the Employer's Affected Property entry and security control, permits and Affected Property regulations.

4.1.2.4 The Contractor ensures that all his Service staff, labour, and Equipment remains within his allocated and fenced off working Area.

4.1.2.5 All Contractor's staff and labour working within port complies with Transnet Port Terminals operational safety requirements and are equipped with all necessary personnel protective equipment (PPE).

4.1.3 People restrictions on Affected Property; hours of work, conduct and records:

The service provider keeps daily records of his people engaged on the Affected Property with access to such daily records available for inspection by the Service Manager at all reasonable times.
