#### 4. RFQ Specifications

Umgeni Water laboratories require Combine bench or wall mounted RO and ultra-pure water purification system. The laboratory uses the RO and ultra-pure water for the preparation of various bacteriological agar and reagents. A detailed specification of the Combine bench or wall mounted RO and ultra-pure water purification system is provided below. Therefore, suppliers are required that can supply and deliver Combine bench or wall mounted RO and ultra-pure water purification system.

##### **SPECIFICATIONS FOR COMBINE BENCH OR WALL MOUNTED RO AND ULTRA-PURE WATER PURIFICATION SYSTEMS DIRECTLY PRODUCED OF POTABLE TAP WATER.**

- The RO system should have a storage tank of 60 litres made of polyethylene.
- The feed water tank for RO water must be protected against airborne contaminants
- The RO system must have a built in conductivity meter to display accurate water quality.
- The RO system must be able to remove particles larger than 5 µm.
- The RO system must be able to remove 95 – 99% feed water contaminants (Ion, bacteria, particles and organics).
- The RO system must be able to filter chlorine in feed water to protect RO cartridges.
- The RO system must be able provide information on the reservoir level.
- The ultra-pure water system must able to produce and display analytical grade pure water of a conductivity of 0.055 µS/cm at 25°C, (18.2 MegOhm-cm).
- The ultra-pure system should have a built-in UV lamp for the reduction of bacteria and TOC levels below 3.0 ppb.
- The ultra-pure water produced must be bacteria (cfu/ml), DNase, RNase and DNA free
- The ultra-pure water system should be able to deliver a permeate flow rate of 1.5 l/min or better.
- The ultra-pure system must show or indicate maintenance intervals, replacement of cartridges and any fault(s) in the system.

##### **Special Conditions**

- The instrument shall be guaranteed against defective workmanship and material for a minimum period of 12 months commencing from the date of commissioning of the instrument.
- The response for repairs of equipment time shall be <48 hours without the need for service contract.
- The tenderer shall carry adequate stocks of spares and consumables in SA.
- Wall bracket for 60 l tank
- Basic training must be supplied by the tenderer.
