Procurement Specification: Single-Channel Micropipettes and Automatic Pipette Fillers

This specification defines the minimum technical, quality, calibration, and documentation requirements for the supply of single channel fixed and adjustable volume micropipettes and automatic pipette fillers for use in an accredited laboratory environment. All equipment supplied under this contract shall be new and supported by calibration certificates issued by a SANAS-accredited laboratory to ISO/IEC 17025.

1. Scope of Supply

- Fixed-volume single-channel micropipettes: 0.25 mL; 0.5 mL; 5 mL; 10 mL (4 units total).
- Adjustable-volume single-channel micropipettes (3 units total):
 - 0.10–1.00 mL
 - 1.00–5.00 mL
 - 1.00–10.00 mL
- Automatic pipette fillers: 4 units, suitable for glass/plastic serological pipettes from 1 mL to 100 mL (calibration certificate **NOT** required)

2. Applicable Standards

- ISO/IEC 17025 (latest edition): General requirements for the competence of testing and calibration laboratories (for calibration provider).

3. Technical Requirements — Micropipettes

- Type: Single-channel, air-displacement micropipettes.
- Ergonomics: Lightweight, low plunger force, adjustable thumbwheel, and clearly readable volume indicator; finger-hook or equivalent support.
- Autoclavability: Lower assembly (shaft/cone) and tip ejector autoclavable at 121 °C for 15 min or fully autoclavable without performance drift; supplier to state which components are autoclavable.
- Chemical resistance: Wetted parts resistant to common laboratory disinfectants and alcohols; PTFE seals or equivalent where applicable.
- Tip compatibility: Compatible with standard universal tips.
 - Each micropipette to be supplied with 100 compatible tips minimum.
- Spare parts: Include one seal/oring kit per micropipette and a service tool (wrench) where applicable.

4. Ranges and Calibration Points — Micropipettes

Fixed-volume models:

- 0.25 mL; 0.50 mL; 5.00 mL; 10.00 mL — each calibrated at the fixed nominal volume.

Adjustable-volume models:

- 0.10–1.00 mL, calibrated at 0.10 mL, 0.50 mL, and 1.00 mL.
- 1.00–5.00 mL, calibrated at 1.00 mL, 3.00 mL, and 5.00 mL.
- 1.00–10.00 mL, calibrated at 1.00 mL, 5.00 mL, and 10.00 mL.

5. Metrological Performance and Tolerances — Micropipettes

- Performance shall conform to ISO 8655 systematic error (accuracy) and random error (precision) limits for the stated nominal volumes. Supplier shall provide the ISO 8655 table values claimed for each model and volume setting.

- Calibration interval: 24 months. Supplier includes a reminder schedule and sticker with next-due date.
- Traceability: Mass standards used for gravimetry to be traceable to national/international standards; traceability chain shown on the certificate.

7. Technical Requirements — Automatic Pipette Fillers

- Volume range: Suitable for serological pipettes from 0.1 mL to 100 mL.
- Flow control: Variable aspiration/dispense speed with fine control trigger.
- Filtration: Hydrophobic in-line filter(s) (e.g., 0.45 μm or manufacturer's equivalent) to protect motor and internal components; supply 20 filter sets total.
- Stand & power: Bench/stand holder included for each unit; rechargeable battery with charger (100–240 V, 50/60 Hz)
- Compatibility: Accepts standard glass and plastic serological pipettes (1 mL to 100 mL). Nosepiece autoclavable or with replaceable sterile filter barrier.
- Weight & ergonomics: Lightweight handheld design (≤ 250 g including battery). Low vibration, low noise.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
