The successful tenderer will have to weigh their vehicle empty and produce a weigh bridge certificate before loading the scrap material. Once the vehicle is loaded the scrap dealer will be accompanied by an Eskom representative at Weigh Bridge to have the scrap material weighed.

This certificate must be authorized and forwarded to the Asset Disposal Officer for verification. Payment will be made on the actual weight at the end of the month's collections.

The following will form part of the tender issue and will also be discussed at the clarification meeting:
All truck drivers obtain a Valid Induction Permit

All trucks must have a valid vehicle permit and be roadworthy to enter **Lethabo Power Station**

Green Colour Coded Skips to be placed at strategic and high-volume areas at the plant may be requested
