1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to establish a panel of experienced Recruitment Service Providers for 24 months for the KZN Growth Fund Agency (KZNGFA).

2. BACKGROUND

KZN Growth Fund Agency (KZNGFA) is a fund, established and capitalised by the Provincial Government to provide debt and equity. The main objectives of the KGFT is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KZNGFA, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KZNGFA Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KZNGFA.

The KZNGFA wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED WORK AND DELIVERABLES

KZN Growth Fund Agency (KZNGFA) hereby requests experienced and reputable service providers to submit proposals in respect of Recruitment Service Providers

3.1 SCOPE OF WORK

3.1.1 Recruitment Service Providers

Recruitment Service Providers for KZNGFA as follows:

- Source suitable candidates for a job opening (all levels);
- Sourcing of rapid temporary staff (emergency staff requirement of less than 24 hour notice)
- Source applicants in line with EE targets
- Screening applicants;
- Interviewing and assessing prospective applicants;
- Preparing CVs for candidates;
- Previous/current employment verifications for prospective applicants; and
- Act as intermediary between KZNGFA & the applicants.

3.2 Contract Period

The contract period will be for a twenty-four (24) months duration.

3.3 Panel Utilization Guidelines

- Once the panel is selected and appointed, formal request from HR will be issued to the panel.
- The selection of service providers from the panel for the RFQ process will be on a rotational basis. CVs will be sourced from the panel in line with the contracted/ approved rates.
- **KZNGFA** reserves the right to appoint a limited number of bidders to the panel of Experts/ Service Providers for the provision of Professional Services to the **KZNGFA** and will apply the provisions of the PPPFA in determining the Top Scoring Bidders. **KZNGFA** reserves the right to increase or decrease the number of consulting firms appointed to the panel.
- The contracting of service providers for specific work assignments will be facilitated by the Human Resource department respectively for **KZNGFA**.
- There is no guarantee that a service provider on the panel will be contracted for specific work assignments/project during the tenure of this contract.

- Service providers that have been appointed to the Panel of Experts for the respective type of services will be approached and be requested to provide CVs at the time the service is required
- Assignments/projects will be clearly defined in terms of the scope of work and/or work packages, proposed timeframes, qualifying criteria, qualification requirements, expected duration (hours) amongst others.
- The **KZNGFA** SCM department and **KZNGFA** will be responsible for the Service Level Agreements for specific work assignments/projects.
- **KZNGFA** reserves the right to procure its requirements elsewhere should the minimum contract specified by the bidder from the panel be more than that of the institution's requirements or if the services are promptly required and not appropriately available from the panel members or in other cases, or urgency.
- The **KZNGFA** SCM Department reserves the right to allocate work packages/projects to more than one service provider/expert, depending on the nature of the assignment/project.
- Travel expenses must be line with the cost containment instruction note.

4. EVALUATION OF QUOTATIONS

Selection will be conducted over two stages:

Stage 1 – Compliance with minimum requirements

Stage 2 – Functionality Requirements

Stage 3 – Price and Specific Goals

4.1 Compliance with minimum requirements

All proposals must be signed accompanied by the following documents:

- 4.1.1 Company Profile;
- 4.1.2 Signed and completed SBD 1, 4 and 6.1
- 4.1.3 Evidence of registration on the National Treasury Central Supplier Database (Tax Compliance Status Pin on a SARS letterhead must be provided should the Tax Compliance status on the CSD report be non-compliant).
- 4.1.4 Recruitment Service Providers – Member of The Federation of African Professional Staffing Organisations (APSO) or equivalent body valid on closing date.

All bids duly lodged as specified in this RFQ will be examined to determine compliance with the mandatory requirements and conditions. Failure to provide any mandatory information as requested above will results in the submission being deemed non-responsive.

4.2 Functionality Evaluation

Scores will be tabulated to 60 points. Respondents must score 42 points and over to be assessed on their financial offer and preference score.

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
