4. Bidders who have elected to download the bid document must submit the complete original completed bid document together with all supporting documents at the close of bids
5. The bid documents must be downloaded or purchased and collected prior to the starting time of the pre-tender briefing meeting.
6. No late arrivals will be admitted to the pre-tender briefing meeting.
7. Late submissions will not be accepted.
8. Posted, Faxed or e-mailed bids are not accepted.
9. Only Bidders registered on the Central Suppliers Database are eligible to submit bids.
