1. BACKGROUND

The IDT is a Schedule 2 state owned entity that manages the implementation and delivery of critically needed social infrastructure programmes on behalf of government. The social infrastructure programmes include public schools, hospitals, courts, correctional services facilities, clinics, community centres, government offices. The IDT reports to the Minister of Public Works who is the Shareholder representative and its Executive Authority. Its national office is located in Pretoria and has regional offices in all of the country's nine provinces.

2. CONTEXT

The organisation is in the process of renewal and, therefore, there is a need to build capacity in terms of the number of employees and skills. This has therefore evoked the need to capacitate the IDT with relevant skills to deliver on its KPIs as outlined in the Annual Performance Plan.

3. PROBLEM STATEMENT

The IDT currently doesn't have the requisite capacity to implement its mandate.

4. COMPULSORY REQUIREMENT

The service provider is expected to perform the following functions:

5.1 External Recruitment and this will include the following:

5.1.2. Response Handling will include the following:

- i. Advertising of positions;
- ii. Receiving and Screening of CVs';
- iii. Compiling of the long list and short-list;
- iv. Compiling of a summary of shortlisted CVs';

- v. Submitting shortlist and summary to HR;
- vi. Verifying and checking of qualifications and conducting background Checks;
- vii. Assessing competencies of recommended candidates;
- viii. Procuring temporary employees;
- ix. Head Hunting.

6. EXPECTED RESULTS

- 6.1 Assist HR with meeting deadlines as per the Service Level Agreement with line function.
- 6.2 Recruiting the right calibre of candidates to meet the IDT's vision.

7. REQUIRED EXPERTISE

The service provider must have proficient knowledge and experience in recruiting and selecting prospective employees on a temporary and permanent basis. The focus of the prospective service provider will be in the following areas:

- 7.1.1 Experience in placing adverts;
- 7.1.2 Response Handling expertise;
- 7.1.3 Must have screening and shortlisting expertise;
- 7.1.4 Must be competent in compiling Executive Summaries;
- 7.1.5 Must have experience in conducting/coordinating verification checks;
- 7.1.6 Experience in head hunting skilled candidates.

8. PROCUREMENT APPROACH

- 8.1 The required services shall be procured through an open advert;
- 8.2 Companies shall submit their proposals consisting of the following:

9. EVALUATION CRITERIA FOR FUNCTIONALITY

The tender will be evaluation in line with the IDT Supply Chain Management Policy and the PPPFA of 2017:

The 80/20 Preference Points system will be used where 80 points are for price and 20 points are for Preference/B-BBEE as cited above.
