TERMS OF REFERENCE – APPOINTMENT OF A SERVICE PROVIDER FOR THE PROVISION OF LAUNDRY SERVICES FOR ADDO ELEPHANT NATIONAL PARK FOR A PERIOD OF THREE (03) YEARS

INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The business unit responsible for this bid is the Tourism Unit of the Addo Elephant National Park which is responsible for the control and management of tourist facilities within the park.

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a proposal for the Provision of Laundry Services for the Addo Elephant National Park.

CONTRACT PERIOD

The contract will be for a period of three (3) years

SCOPE OF WORK

Addo Elephant National Park has a fully equipped in-house laundry facility which is used for washing and ironing of guest's linen. The laundry facility is fitted with industrial laundry equipment such as Speed Queens washing machines and tumble dryers, Tullies roller irons. These washing machines are fitted with dosing machines which supply liquid chemicals for washing of linen. The park has identified a need to improve its business operations to cater for the needs of the guests. In order to achieve this, the Park has decided to out-source the laundry services and enter into a contract with a service provider for supply of labour for washing and ironing of guest's linen.

1. SPECIFICATION

The following services will be required.

- Washing of all linen at the correct temperature using the right detergent to remove blood and other stains remover at the in-house laundry room as per Laundry process management and park guidelines/procedure.
- Linen must be disinfected during the washing process, in order to ensure that it conforms to health and safety requirements (SANS 10146), service provider will be inducted
- Blood stained and infected linen must be firstly washed separately and then washed again in routine wash. All stains must be removed from linen – such as rust and mill dew.
- Where it is not possible for stains to be removed, the service provider must bring this to the attention of the Addo Tourism Management

- Ironing of laundry at the correct temperature as per Laundry process management and park guidelines/procedure.
- Items damaged due to the service provider negligence will be replaced at the service provider's costs
- Losses at the laundry will be for the service provider's cost. The bidder must submit proof that reasonable arrangement have been made to compensate SANParks for any loss that SANParks may suffer while linen is under the contractor's possession
- Linen that needs special treatment such as dry cleaning to be cleaned accordingly (i.e. curtains).
- Linen must be well presented when delivered, ironed and folded.
- All issues regarding this contract are to be communicated with the Addo Tourism Management
- No work is to be left unfinished unless authorized by Addo Tourism Management
- The service provider to provide good quality laundry bags for soiled and clean linen. The bag must have proper closing mechanism. Bags for soiled linen to be clearly marked (permanent labelling or colouring)
- The laundry bags must be properly sealed to avoid loss and the seal number be recorded by both the service provider and SANParks
- Provide transparent laundry bags for dirty, cleaned, and stained linen (e.g. linen with blood stains). The size of the bags will be specified after the bid is awarded and replacement on the service provider's cost
- The service provider will be notified in writing of sub-standard services.
- SANParks reserves the right to return any linen not cleaned according to their standards. Costs of this will be for the account of the bidder and guideline will be provided on that.
- Cleaning of laundry machines and other equipment should be done on daily basis- (Guidelines or Standard Operating Procedures will be provided to the supplier)
- Emptying of waste bins on daily basis in the laundry area.
- Cleaning of walls, doors and windows once a month
- Ad-hoc duties on daily basis.
- Uphold and comply with cleaning standards of SANParks.
- Sorting of linen and weighing thereof to ensure correct amount in machines
- Sweeping & mopping of floors.
- Keep record of incoming and outgoing linen on daily basis – including the soiled linen
- Report on a daily basis of damaged linen / stained and must have the register for that and should be provided to Housekeeper
- Keep a daily occurrence book of all activities, visitors, incidents in the laundry and report to Tourism Management
- Report the faulty machinery and challenges encountered immediately to Tourism Management
- Keep record of all chemicals / detergents on a daily basis and record of usage to be provided to Tourism Management at the beginning of the shift

2. DESCRIPTION OF SOILED TEXTILES REQUIRING LAUNDRY SERVICE

This includes but not be limited to bed sheets, pillow cases, pillow covers, blankets, duvets, duvet covers, mattress covers, mats, curtains and towels.
