PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or

at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

1. BACKGROUND

The South African Diamond and Precious Metals Regulator (SADPMR) needs to appoint a bidder at its Head Office in Kempton Park. The appointed bidder should render service to supply a public address system. This will include, deliver, install, commission of public address system and provide maintenance, service and repairs at the SADPMR's head office in Kempton Park for a period of three years (36 months), for 24 hours, 7 days once installed.

2. SCOPE OF SERVICE

- 2.1. The appointed bidder will render service to supply public address. This include deliver, install, commission, maintenance, service and repairs at the SADPMR's head office in Kempton Park for a period of three years (36 months), for 24 hours, 7 days at all times as follows:

2.1.1. Duration of the maintenance of the contract

- 2.1.1. This call out service contract shall commence upon SADPMR issuing a letter of appointment, purchase order and after signing a Service Level Agreement which will be for a period of three years (36 months).

3. REPAIR AND RESPONSE TIMES

- 3.1. Should it be detected during the maintenance process that the PA system is not functional; the bidder should write a report and identify the required repairs immediately.
- 3.2. Response time shall be within six (6) hours on-site after bidder receives request from the SADPMR.
- 3.3. An emergency request that occurs during working hours shall be four (4) hours without carryover into the next day.

5. HOURS OF WORK

- 5.1. The bidder shall undertake to carry out the maintenance process during normal working hours and when need arise work after hours shall be considered.
- 5.2. Equipment repair shall be determined by the nature of fault findings and a report shall be provided.

6. PERSONNEL SUITABILITY CHECK

- 6.1. It is a specific condition of this contract that bidder and their personnel will be security screened.
- 6.2.
