INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Conservation Services Unit within the Karoo National Park falls under Parks Division (SANParks) with its mandate of conserving, protecting, controlling and managing the protected areas and biodiversity

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a proposal for the provision of gate access control in Karoo National Park (Beaufort west) for a period of five (5) years.

CONTRACT PERIOD

The contract will be for a period of FIVE (5) years

SPECIFICATIONS/SCOPE OF WORK

SANParks seeks to appoint a reputable and professional security services company for provision of access control at the main entrance gate of Karoo National Park, in Beaufort West Although Karoo National Park has its own gate guard on duty during office hours at the main gate, additional security guards are required to man the gate after office hours and during weekends and public holidays. The services would be for access control only, therefore the security guard grading on grade C would be sufficient. Only one security guard would be required to work at the main gate except in cases where training needs to be given to additional security guards when more than one security guard may be present at the main gate.

SPECIFICATIONS

SERVICES REQUIRED: A service will be required 365 days of the year and would include the following;

- Night shift duties on Mondays to Sundays from 16:00 till 7:00 (next morning).
- Day shift duties on Saturdays, Sundays and Public Holidays from 7:00 till 16:00.
- A 30 day period when the permanent gate guard is on leave.
- The work will entail access control according to the Standard Operating Procedures (SOP)
 Access Control for Karoo NP, this document will be made available to the successful service provider.

- Completion of gate registrations and indemnity dockets for all guests.
- Declaring, sealing and registering of fire arms of visitors.
- Radio duties as required by SANParks.
- Completion of official registers.
- Provide keys to late arrivals (guests).

Note:

- The site to be serviced is Karoo National Park.
- Security services company must be registered with the Private Security Industry Regulatory Authority (PSIRA)
- Guards must also be registered with PSIRA
- Security Company must also attach a list of permanent Registered guards
- Company must ensure quality service
- Guards must be well trained in security services and must have traceable references
- Guards must not have any criminal records
- Guards must be able to communicate in English and Afrikaans
- Guards must be punctual

REQUIREMENTS OF STAFF:

i) Training

Staff should have relevant training and registration with PSIRA. Staff should at least be able to communicate in English as well as in Afrikaans and be able to read and write both languages. All staff working at Karoo NP's main gate should undergo induction training by SANParks that would include Code of Conduct SANParks, Rules and Regulations, SOP – Access Control, Legislation applicable to Protected Areas. This training would be provided by SANParks and it is expected from the service provider to avail all staff and relief staff to attend this training.

ii) Uniform

It is expected from the service provider to provide uniform to the security guards that will be in line with the image and profile of SANParks and as prescribed by the Security Industry Regulation Authority. It will be expected from all security guards to report to work in full uniform. Their uniform should make provision for colder weather as well, especially during the winter period. Jackets and/or rain coats should be provided.

iii) Transport

The service provider is responsible for the transport of its own staff to and from the work place. An overnight facility will be made available to the security guards during night shifts. This facility is situated at the main entrance gate.

iii) Performance Management

The service provider should have a performance measurement system in place to evaluate and manage performance of its employees.

It is also advised that the service provider shall have a duty sheet to ensure all staff on duty are familiar with the duties as required in the contract. The service provider shall thus have a comprehensive duty sheet prominently displayed at each point where security service is provided

iv) Operational Equipment

The following equipment would be expected to be supplied by the service provider to the security guards;

- Black pens
- Flash light with extra batteries
- A two-way portable radio with communication with the control room of the service provider.
- Incident report book
- Security equipment discretion of the service provider but at least one can of pepper spray per security guard.
- Uniform that could identify the employee as a security guard and approved by Karoo National Park.

v) Discipline and Code of Conduct

The Contractor will immediately remove a security guard from its duties within the Park should SANParks provide evidence of –

- Bribery, theft, on duty while under the influence of alcohol or drugs, sleeping on duty, Contravention of uniform rules, not being polite and presentable, eating and drinking while working with the public, chewing gum while working with the public, littering and not preventing littering, negligence in recording people and vehicles entering the Park, incorrect recording of detail in the official registers, deviation from search instructions.
- The above mentioned action should provide grounds for removal of a security guard from its duties within the Park.
- The Contractor undertakes to investigate and take disciplinary action against a security guard against whom SANParks has a complaint if deemed necessary.
- Security guards with a negative criminal record.

Day shift duties on Saturdays, Sundays and Public Holidays from 7:00 till 16:00	 Guards are responsible for the security of SANParks visitor facilities; buildings, vehicles, all equipment and assets, managing access control sheet, checking of guest permits, searching of vehicles at the main gate. Duties will include patrolling, locking of gates; regular (hourly) patrols of the grounds, check for open doors and windows etc. and managing reporting of illegal access after-hours in line with park entry times, completion of gate registrations and indemnity dockets for all guests. - Ensure that security personnel are well mannered and respectful at all times when on duty;
- Ensure that security personnel do not report on duty drunk or under the influence of intoxicating substances, nor drink intoxicating substances when on duty.
- Ensure that security personnel do not sleep on duty.

- Ensure that security personnel keep all relevant records (entry record, movable property record and exit record register);
- Ensure that security personnel are always available to assist in any form of emergency at the main gate;
- Ensure that management is always available to respond to any complaints from either visitors or SANParks related to security services;
- Ensure that all complaints are addressed and a formal report afforded to SANParks on how the complaint was resolved and how such will be prevented in future within 7 working days from the day of occurrence;
- Maintenance of security services standards that SANParks receives from the Service Provider; and
- Submit invoice together with the attendance register on every last day of the month to SANParks as well as credit notes for late coming and patrolling as recorded by the security monitoring system.
- Effect payment within 30 days from date of receipt of original SANParks tax invoice for non-compliance e.g. late coming and non-compliance.
- Sign off SANParks Standard Operating Procedure within 30 days after submission by SANParks
- Service provider will be required to transport guards to all sites to ensure punctual commencement of shifts

COMPETENCIES OF THE SERVICE PROVIDER

- The service provider shall act in good faith in fulfilling its obligations in terms of these operational requirements.

Contracted Party Due Diligence

SANParks reserves the right to conduct supply chain due diligence including site visits and inspections at any time during the contract period.

Jigs, Tools, and Templates, where applicable

Unless otherwise agreed, all jigs, tools, templates, and similar equipment necessary for the execution of this contract is property of SANParks, if SANParks has paid for these. On completion or cancellation of the contract, the contractor delivers all SANParks property to SANParks premises, properly marked with the contract and the relevant code number as supplied by SANParks.

Copyright and Intellectual Property

All background intellectual property (existing prior to this contract) invests in and remains the sole property of the contributing party to this contract and/or the contracted discloses the same to SANParks at the commencement of this contract. The contracted supplier grants SANParks a fully paid up, irrevocable, non-exclusive, and transferable licence to use its background intellectual property including the right to sub-licence to third parties in perpetuity and to the extent that SANParks requires for the exploitation of the contract intellectual property and to enable SANParks to obtain the full benefit of the contract intellectual property.

The parties agree that all right, title, and interest in the contract intellectual property rightly invests in SANParks and to give effect to the foregoing:

- (a) The contracted supplier hereby assigns all rights, titles, and interests in and to the contract intellectual property that it may own to SANParks and SANParks hereby accepts such assignment, and
- (b) The contracted supplier undertakes to assign in writing to SANParks all contract intellectual property and which may invest in the contracted supplier.

The contracted supplier shall keep the contract intellectual property confidential and shall fulfil its confidentiality obligations as set out in this document.

The contracted supplier shall assist SANParks in obtaining statutory protection for the contract intellectual property at the expense of SANParks wherever SANParks may choose to obtain such protection. The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to SANParks, or as SANParks may direct, and to support SANParks, or its nominee, in the prosecution and enforcement thereof in any country in the world.

The contracted supplier hereby irrevocably appoints SANParks to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that SANParks, in its absolute discretion, requires in order to give effect to the terms of this clause.

The rights and obligations set out in this clause shall service termination of this contract indefinitely.

Confidentiality

The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not:

- (a) Disclose the confidential information, directly or indirectly, to any person or entity, without SANParks' prior written consent.
- (b) Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or
- (c) Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.

The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to

- (a) Disclose the confidential information to any third party, or
- (b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- (a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks;
- (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or
- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in

documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
