**2. SUPPLY, DELIVER AND REUPHOLSTER OF INDOOR FURNITURE FOR BALELE GAME PARK:**

### Local Production and Content:

Only locally produced goods that meet the stipulated minimum threshold for local production and content as determined by dti will be considered for acceptance.

### Specification:

Only locally produced goods or services that meet the minimum threshold stipulated on MBD 6.2 for local production and content as determined by dti will be considered for acceptance. Any tender that does not meet the minimum threshold is an unacceptable tender.

**ANY TENDERER THAT FAILS TO MEET THE LOCAL PRODUCTION AND CONTENT AS CONDITION OF TENDER REQUIREMENTS WILL BE DEEMED INVALID.**

Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates which is accredited by SANS or certified copies of sworn affidavit thereof together with their bids, to substantiate their B-BBEE rating claims. Failure to submit the proof of B-BBEE Certificate or sworn affidavit will result in forfeiting the points. **Valid Tax compliant status, proof of registration on central supplier database and company registration certificate must be submitted together with the tender document.** Service provider must be registered on Municipality's database.

Tender documents will be available at Emadlangeni Municipality (Cashiers desk) at a non-refundable fee, at number 34 Voor Street, Utrecht, 2980.

**Sealed bids endorsed "Tender number and description as reflected above".** Tender documents must reach the Emadlangeni Municipality and be placed in the tender box at the reception of the Municipal buildings, 34 Voor Street, Utrecht by no later than 12:00pm of the closing date. Then, they will be opened in public in the Municipal Reception Area. No facsimiled, emailed or telegraphic tenders will be accepted.
