SECTION 1: BACKGROUND, OVERVIEW AND RFP SCOPE OF REQUIREMENTS

1 BACKGROUND

The National Lotteries Commission (NLC) is a public entity established by Lotteries Act No. 57 of 1997 as amended to regulate the South African lotteries industry. The functions of the Commission can be divided into two categories, namely “regulation of National Lottery and other Lotteries” and “administration of the National Lottery Distribution Trust Fund (NLDTF)”.

The NLC operates in nine provinces with the head office located in Hatfield in the Gauteng province. Presently a national private MPLS network interconnects each of the provincial offices to the head office. A central server room at the Hatfield office houses all the core applications, servers and associated network infrastructure. This MPLS network caters for both SIP telephony services as well as data network services. ICT performs annual infrastructure reviews on information Security to identify any vulnerabilities.

The NLC invites suitably qualified and experienced bidders to submit proposals for implementing a Security Incident and Event Management (SIEM) at NLC Head Office. In line with the requirements of the Public Finance Management Act (PFMA) No. 1 of 1999 and Treasury Regulations, the NLC seeks to engage the services of a duly service provider.

2 SCOPE OF WORK

The SIEM solution requirements include the supply, installation, configuration of a new SIEM application,

1. Solution Architecture
 - a. Deployment model must be Cloud solution
 - b. Database engine model
 - c. Security provisions
 - d. Data storage model
2. Project implementation methodology: -
 - Project rollout timelines
 - Testing and validation of solution
3. Service level agreement
4. Skills transfer plan to NLC resources
 - Develop the training manual
 - Conduct the training

4. REQUIREMENTS

4.1 Implementation Requirements

The managed SIEM service must have the ability to do the following: -

- **Log monitoring**

Solution must provide a built-in platform for centralized log monitoring and management. It must ingest logs from different sources such as Windows servers, VMWare, SQL DBs, Network Devices, PBX appliances and others.

- **Detection Of Brute Force Attack**

Capability to correlate these logs to enable detection of potential cyber security threats

- **Detection Of Malware Activity**

Capability to correlate these logs to enable detection of potential cyber security threats.

- **Detection of Suspicious User Behaviour**

Capability to correlate these logs to enable detection of potential cyber security threats

- **Detection Of Suspicious Network Behaviour**

Capability to correlate these logs to enable detection of potential cyber security threats in terms of:

- **Suspicious Device Behaviour**

Capability to correlate these logs to enable detection of potential cyber security threats

- **Track System Changes and Authentication**

Capability to correlate these logs to enable detection of potential cyber security threats

- **Continuous Compliance Management**

Capability to correlate these logs to enable detection of potential cyber security threats

- **Detection Of Unknown Threats**

Capability to correlate these logs to enable detection of potential cyber security threats

The solution must be able to correlate logs from various sources across the enterprise and be able to detect threats that are unknown.

3 DELIVERABLES

The following deliverables identified as project outputs:

- A fully configured and functional SIEM solution as a managed service.
- Incident management support and malware analysis
- Threat analysis and intelligence, and mitigation strategies and recommendations documentation.
- Fully trained ICT personnel on the configured SIEM

4 REPORTING REQUIREMENTS

The successful service provider will report to the Information Communications Technology Division.

5 DURATION OF THE PROJECT

The project will commence on a day to be agreed upon by NLC and the bidder. The successful bidder will be required to execute and conduct the following services for the NLC for a period of 6 months.

SECTION 2: NOTICE TO BIDDERS

1. Terms and conditions of Request for Proposals (RFP)

- 1.1 This document may contain confidential information that is the property of the NLC.
- 1.2 No part of the contents may be used, copied, disclosed, or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this RFP without prior written permission from the NLC.
- 1.3 All copyright and intellectual property herein vests with the NLC.
- 1.4 Late and incomplete submissions will not be accepted.
- 1.5 No services must be rendered, or goods delivered before an official NLC Purchase Order form has been received.
- 1.6 This RFP will be evaluated in terms of the 80/20 preference point system prescribed by the Preferential Procurement Regulations, 2022.
- 1.7 Suppliers are required to register on the Central Supplier Database at www.csd.gov.za.
- 1.8 Suppliers must provide their CSD registration number (and attach a CSD Summary report) and ensure that their tax matters are compliant. Bidders' tax affairs must be in order at the closing date & time of bid submission.
- 1.9 All questions regarding this RFP must be forwarded to bids@nlcsa.org.za, no later than within three days of the RFP closing date.
- 1.10 Any supplier who has reasons to believe that the RFP specification is based on a specific brand must inform the NLC via the email addressed in 1.9.

2. General rules and instructions

- 2.1 News and press releases
 - 2.1.1 Bidders or their agents shall not make any news releases concerning this RFP or the awarding of the same or any resulting agreement(s) without the consent of, and then only in co-ordination with, the NLC.
- 2.2 Precedence of documents
 - 2.2.1 This RFP consists of a number of sections. Where there is a contradiction in terms between the clauses, phrases, words, stipulations or terms and herein referred to generally as stipulations in this RFP and the stipulations in any other document attached hereto, or the RFP submitted hereto, the relevant stipulations in this RFP shall take precedence.
 - 2.2.2 Where this RFP is silent on any matter, the relevant stipulations addressing such matter, and which appear in the PPPFA shall take precedence. Bidders shall refrain from incorporating any additional stipulations in its proposal submitted in terms

hereof other than in the form of a clearly marked recommendation that the NLC may in its sole discretion elect to import or to ignore. Any such inclusion shall not be used for any purpose of interpretation unless it has been so imported or acknowledged by the NLC.

- 2.2.3 It is acknowledged that all stipulations in the PPPFA are not equally applicable to all matters addressed in this RFP. It, however, remains the exclusive domain and election of the NLC as to which of these stipulations are applicable and to what extent. Bidders are hereby acknowledging that the decision of the NLC in this regard is final and binding. The onus to enquire and obtain clarity in this regard rests with the Bidder(s). The Bidder(s) shall take care to restrict its enquiries in this regard to the most reasonable interpretations required to ensure the necessary consensus.

2.3 Preferential procurement reform

- 2.4 The NLC supports B-BBEE as an essential ingredient of its business. In accordance with government policy, the NLC insists that the private sector demonstrates its commitment and track record to B-BBEE in the areas of ownership (shareholding), skills transfer, employment equity and procurement practices (SMME Development) etc.

2.5 National Industrial Participation Programme

- 2.6 The Industrial Participation policy, which was endorsed by Cabinet on 30 April 1997, is applicable to contracts that have an imported content. The NIP is obligatory and therefore must be complied with. Bidders are required to sign and submit the Standard Bidding Document (SBD).

2.7 Language

- 2.7.1 Bids shall be submitted in English.

2.8 Gender

- 2.8.1 Any word implying any gender shall be interpreted to imply all other genders.

2.9 Headings

- 2.9.1 Headings are incorporated into this RFP document and submitted in response thereto, for ease of reference only and shall not form part thereof for any purpose of interpretation or for any other purpose.

2.10 Occupational Injuries and Diseases Act 13 of 1993

- 2.10.1 The Bidder warrants that all its employees (including the employees of any sub-contractor that may be appointed) are covered in terms of the Compensation for Occupational Injuries and Diseases Act 13 of 1993 and that the cover shall remain in force for the duration of the adjudication of this RFP and/ or subsequent agreement. the NLC reserves the right to request the Bidder to submit documentary proof of the Bidder's registration and "good standing" with the Compensation Fund, or similar proof acceptable to the NLC.

- 2.11 Processing of the Bidder's Personal Information
- 2.11.1 All Personal Information of the Bidder, its employees, representatives, associates and sub-contractors ("Bidder Personal Information") required under this RFP is collected and processed for the purpose of assessing the content of its tender proposal and awarding the bid. The assessment and award of the bid shall be conducted in accordance with applicable legislation including the PPPFA read with the Preferential Procurement Regulations, 2017. The Bidder is advised that Bidder Personal Information may be passed on to third parties to whom the NLC is compelled by law to provide such information. For example, where appropriate, the NLC is compelled to submit information to National Treasury's Database of Restricted Suppliers.
- 2.11.2 All Personal Information collected will be processed in accordance with POPIA and with the NLC Data Privacy Policy.
- 2.11.3 The following persons will have access to the Personal Information collected:
- 2.11.3.1 The NLC personnel participating in procurement/award procedures; and
- 2.11.3.2 Members of the public: within seven working days from the time the bid is awarded, the following information will have to be made available on National Treasury's e-Tender portal:
- 2.11.3.2.1 contract description and bid number;
- 2.11.3.2.2 names of the successful bidder(s) and preference points claimed;
- 2.11.3.2.3 the contract price(s) (if possible);
- 2.11.3.2.4 contract period;
- 2.11.3.2.5 names of directors; and
- 2.11.3.2.6 date of completion/award.
- 2.11.4 The NLC will ensure that the rights of the Bidder and of its employees and representatives (i.e. the right of access and the right to rectify) are effectively guaranteed in accordance with the procedures as specified in the NLC PAIA manual.
- 2.11.5 In signing this document, the Bidder consents to the use of its Personal Information for the purposes as specified in section 2.9.1 above.

3. Formal Briefing Session

There will be no compulsory briefing session.

4. Validity Period

- 4.1 The NLC requires a validity period of 120 [one hundred and twenty] Business Days [from closing date] against this RFP.
- 4.2 Bidders are to note that they may be requested to extend the validity period of their bids, on the same terms and conditions, if the internal evaluation process are not finalised within the validity period.

5. National Treasury's Central Supplier Database

- 5.1 Bidders are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information.
- 5.2 The NLC may not award business to a bidder who has failed to register on the CSD.
- 5.3 Only foreign suppliers with no local registered entity need not register on the CSD.

6. Confidentiality

- 6.1 Bids submitted for this Request for Proposals will not be revealed to any other bidders and will be treated as contractually binding;
- 6.2 The NLC reserves all the rights afforded to it by the POPIA in the processing of any of its information as contained in Bid Proposals.
- 6.3 The Bidder acknowledges that it will obtain and have access to personal information of The NLC and agrees that it shall only process the information disclosed by the NLC in terms of this bid award and only for the purposes as detailed in this RFP and in accordance with any applicable law.
- 6.4 The Bidder shall notify the NLC in writing of any unauthorised access to personal information and the information of a third party, through cybercrimes or suspected cybercrimes, in its knowledge and report such crimes or suspected crimes to the relevant authorities in accordance with applicable laws, after becoming aware of such

7. Communication

- 7.1 Specific queries relating to this RFP should be submitted bids@nlcsa.org.za, before the closing date.
- 7.2 In the interest of fairness and transparency the NLC's response to such a query may be made available to other bidders.
- 7.3 It is prohibited for bidders to attempt, either directly or indirectly, to canvass any officer or employee of the NLC in respect of this RFP between the closing date and the date of the award of the business.
- 7.4 Bidders found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

1.2 Bid Formats

Bid submissions must be submitted in a PDF format that is protected from any modifications, deletions, or additions.

Financial/pricing information must be presented in a separate Folder from the Technical/Functional Response information Folder. The onus is on the Bidder to ensure that all mandatory and required documents are included in the electronic submission.

Submissions must be prominently marked with the full details of the tender namely Bidder's Name, Tender No and Tender Title.

Bidders are advised to submit at least thirty minutes before the bid closing time to cater for any possible delay in receipt of the bid. The onus is on bidder to ensure that the bid is submitted on at the right location.

Tender submission USBs received after submission date and time will be declared late bid submissions and will not be accepted for consideration by the NLC.

The NLC will not be responsible for any failure or delay in the email transmission or receipt of the email including but not limited to:
