Vehicle Tracking and Dashcam Technical Specification

1. Background

Onderstepoort Biological Products SOC Ltd (OBP) is a State-Owned Company responsible for the manufacturing and distribution of animal vaccines throughout South Africa. The company operates a fleet of vehicles to support the nationwide marketing and distribution of its products.

To improve fleet visibility, driver safety, vehicle security, operational efficiency, and regulatory compliance, OBP intends to procure and implement a comprehensive Vehicle Tracking and Dashcam Solution

2. Scope of Work

The successful service provider shall supply, install, configure, commission, and maintain a vehicle tracking and dashcam solution for OBP's fleet. The solution shall include all hardware, software, cloud services, mobile applications, training, technical support, maintenance, and warranty.

3. Descriptions and the number of vehicles

Five vehicles tracking installation and monitoring:

- 2 double cabs
- 2 single cabs
- 1 single cab with refrigerated Box

4. Minimum Technical Requirements

4.1 GPS Vehicle Tracking

The system shall:

- Provide real-time GPS tracking with location updates at intervals not exceeding 30 seconds.
- Display the current vehicle location, speed, direction of travel, and ignition status.
- Record complete trip history.
- Operate through a secure cloud-based Fleet Management System.

- Be accessible via both desktop web browsers and mobile applications.
- Allow authorised users to monitor multiple vehicles simultaneously.

4.2 Geofencing

The system shall:

- Allow users to create and manage multiple custom geographic zones (geofences).
- Generate automatic alerts when vehicles enter or exit designated areas.
- Allow naming and categorisation of geofenced locations.

4.3 Trip Management and Reporting

The system shall provide:

- Trip start and end times.
- Travel distance.
- Route travelled.
- Vehicle speed.
- Stop duration and locations.
- Driver activity reports.
- Historical trip reports.

Reports shall be downloadable and exportable in:

- Microsoft Excel
- PDF

4.4 Driver Behaviour Monitoring

The solution shall monitor and report on:

- Speeding.
- Excessive idling.
- Harsh braking.
- Harsh acceleration.
- Rapid cornering (where available).
- Driver scorecards and performance reports.

4.5 Speed Monitoring

The system shall:

- Monitor vehicle speed against applicable road traffic speed limits.
- Generate configurable speeding alerts.

Include speeding events in management reports

4.6 Ignition Monitoring

The system shall:

- Monitor ignition ON and OFF events.
- Record engine operating times.
- Generate ignition activity reports.

4.7 Tamper Detection

The tracking device shall generate alerts in the event of:

- Power disconnection.
- Device tampering.
- GPS antenna interference.
- Communication interruption.

4.8 Vehicle Recovery

The service provider shall provide support for stolen vehicle recovery, including:

- Real-time vehicle location.
- Assistance with law enforcement agencies where required.
- Emergency tracking support.

4.9 Dashcam System

Each vehicle shall be fitted with a dual camera dashcam consisting of:

- One forward-facing camera recording the road ahead.
- One inward-facing camera recording the vehicle cabin.

The dashcam shall provide:

- Minimum Full HD (1080p) recording.
- Wide-angle lenses.
- Automatic loop recording.
- Night vision capability.
- Integrated GPS and date/time stamping.
- Continuous recording while the vehicle is operating.

4.10 Event Recording

The dashcam shall automatically record and retain footage during:

- Vehicle collisions.
- Impact events.
- Harsh braking.
- Harsh acceleration.
- Panic button activation.
- Other configurable safety events.

4.11 Video Retrieval

The system shall allow authorised users to:

- Retrieve complete video footage relating to specific incidents.
- Search footage by vehicle, date, time and event.
- Download video clips for investigations and insurance purposes.

4.12 Vehicle Maintenance Management

The solution shall provide maintenance reminders based on:

- Vehicle mileage.
- Service intervals.
- Vehicle licence renewal dates.

The system shall generate automated alerts before maintenance or licence expiry dates.

4.13 Panic Button

Each vehicle shall be equipped with a panic button capable of:

- Sending an immediate emergency alert.
- Displaying the vehicle's live GPS location.

- Notifying authorised users via the fleet management platform.
- Recording the associated dashcam footage.

5. General System Requirements

The solution shall include:

- Cloud-based secure data storage.
- User role and permission management.
- Automatic software updates.
- Audit trail of user activities.
- Secure encrypted communication.
- System uptime of at least 99%.

6. Installation Requirements

The supplier shall:

- Supply all required hardware and accessories.
- Professionally install all equipment.
- Conceal wiring to minimise tampering.
- Test and commission each installation.
- Provide user training and system documentation.

7. Warranty and Support

The supplier shall provide:

- Minimum 12-month warranty on all hardware and installation.
- Technical support during business hours.
- Fault response within agreed Service Level Agreements (SLAs).
- Replacement of defective equipment during the warranty period.
