TERMS OF REFERENCE:

INTRODUCTION

The Indigent Management capability is to support a National Free Basic Services framework, that will improve the lives of indigents and enhance access to free basic services. Guided by the Municipal Indigent Policy, municipalities provide a comprehensive range of services that are beneficial to the poor receiving essential services. To be able to reach a far wider community in assisting indigents and providing at least basic municipal services to the poor, the municipality consistently reviews and updates its indigent policy, as well as its indigent verification criteria, to maximize the number of indigent households receiving free basic services. In the long run, it is essential for this level of exclusion to be dealt with through national economic development initiatives, which is beyond the scope of this municipal indigent policy.
