### 1.1 DESCRIPTION OF SERVICE: ANALYSIS

**BACKGROUND:** A Winetech/SA Wine project titled "Authenticity of SA Wines" was approved for funding starting the financial year 1 April 2023. As part of this project NMR, IRMS and possibly IR instrumental analyses must be performed on wines. The aim is to construct an authoritative analytical database, inclusive of all variations caused by grape cultivar, geographic location and vintage, for the authentication (geographical, botanical, dilution, variety and vintage) of South African wines.

**PURPOSE:** NMR authentication of wines (not performed by ARC laboratories).

**SCOPE OF WORK:** South African wines will be authenticated in terms of geographical- and botanical origin, dilution, variety, and vintage.
