

1. INTRODUCTION

During the validation process, certificates that were issued by external training providers for operating / legislative training were submitted as part of the tender returnable (SHEQ and/or technical) and the following were observed:

- 1) Certificates issued without the correct information.
- 2) Certificates issued by non-accredited training providers. These training providers were not listed on the National Facilitators Database.
- 3) Certificates issued by accredited providers that were found to be fraudulent and/or modified issued.

2. SUPPORTING CLAUSES

2.1 SCOPE

To validate certificates issued by external training providers to verify if it complies with the Eskom requirements.

2.1.1 Purpose

The purpose of this Technical Instruction is to ensure that all contractor certificates for operating and/or legislative training are validated by the Learning and Delivery department before being accepted by Eskom business.

2.1.2 Applicability

This document shall apply throughout the Cape Coastal Cluster.

- Shall ensure that validation of certificates forms part of the tender evaluation criteria and process.

2.5.3 SHEQ Officer

- To submit the received certificates to validations@eskom.co.za
- To ensure that the certificates are clear and legible
- To only approve the SHEQ and/or technical files after receiving confirmation validation letters from Learning and Delivery (L&D)

2.5.4 Learning and Delivery

- To validate submitted certificates
 - To record all received certificates on to the validation database
 - To issue and send validation letters to the requestor
- To ensure that certificates are legitimate, issued by accredited facilitators and that the certificates comply to the Power Delivery Operating Assessment, Authorisation and Training Standard: 240-70413865

2.6 PROCESS FOR MONITORING

All certificates that are/were issued by external training providers must be:

- Validated against the National Facilitators Database to confirm that certificates have been issued by accredited training providers.
- Submitted certificates must be verified for authenticity by the External Training provider if required.
- Comply to the Power Delivery Operating Assessment, Authorisation and Training Standard: 240-70413865
