Z1 Cession delegation and assignment

- Z1.1 The *Contractor* does not cede, delegate or assign any of its rights or obligations to any person without the written consent of the *Employer*.
- Z1.2 Notwithstanding the above, the *Employer* may on written notice to the *Contractor* cede and delegate its rights and obligations under this contract to any of its subsidiaries or any of its present divisions or operations which may be converted into separate legal entities as a result of the restructuring of the Electricity Supply Industry.

Z2 Joint ventures

- Z2.1 If the *Contractor* constitutes a joint venture, consortium or other unincorporated grouping of two or more persons or organisations then these persons or organisations are deemed to be jointly and severally liable to the *Employer* for the performance of this contract.
- Z2.2 Unless already notified to the *Employer*, the persons or organisations notify the *Service Manager* within two weeks of the Contract Date of the key person who has the authority to bind the *Contractor* on their behalf.
- Z2.3 The *Contractor* does not alter the composition of the joint venture, consortium or other

unincorporated grouping of two or more persons without the consent of the *Employer* having been given to the *Contractor* in writing.

Z3 Change of Broad Based Black Economic Empowerment (B-BBEE) status

- Z3.1 Where a change in the *Contractor's* legal status, ownership or any other change to his business composition or business dealings results in a change to the *Contractor's* B-BBEE status, the *Contractor* notifies the *Employer* within seven days of the change.
- Z3.2 The *Contractor* is required to submit an updated verification certificate and necessary supporting documentation confirming the change in his B-BBEE status to the *Service Manager* within thirty days of the notification or as otherwise instructed by the *Service Manager*.
- Z3.3 Where, as a result, the *Contractor's* B-BBEE status has decreased since the Contract Date the *Employer* may either re-negotiate this contract or alternatively, terminate the *Contractor's* obligation to Provide the Service.
- Z3.4 Failure by the *Contractor* to notify the *Employer* of a change in its B-BBEE status may constitute a reason for termination. If the *Employer* terminates in terms of this clause, the procedures on termination are P1, P2 and P4 as stated in clause 92, and the amount due is A1 and A3 as stated in clause 93.

Z4 Confidentiality

- Z4.1 The *Contractor* does not disclose or make any information arising from or in connection with this contract available to Others. This undertaking does not, however, apply to information which at the time of disclosure or thereafter, without default on the part of the *Contractor*, enters the public domain or to information which was already in the possession of the *Contractor* at the time of disclosure (evidenced by written records in existence at that time). Should the *Contractor* disclose information to Others in terms of clause 25.1, the *Contractor* ensures that the provisions of this clause are complied with by the recipient.
- Z4.2 If the *Contractor* is uncertain about whether any such information is confidential, it is to be regarded as such until notified otherwise by the *Service Manager*.
- Z4.3 In the event that the *Contractor* is, at any time, required by law to disclose any such information which is required to be kept confidential, the *Contractor*, to the extent permitted by law prior to disclosure, notifies the *Employer* so that an appropriate protection order and/or any other action can be taken if possible, prior to any disclosure. In the event that such protective order is not, or cannot, be obtained, then the *Contractor* may disclose that portion of the information which it is required to be disclosed by law and uses reasonable efforts to obtain assurances that confidential treatment will be afforded to the information so disclosed.
- Z4.4 The taking of images (whether photographs, video footage or otherwise) of the Affected Property or any portion thereof, in the course of Providing the Service and after the end of the *service period*, requires the prior written consent of the *Service Manager*. All rights in and to all such images vests exclusively in the *Employer*.
- Z4.5 The *Contractor* ensures that all his subcontractors abide by the undertakings in this clause.

Z5 Waiver and estoppel: Add to core clause 12.3:

- Z5.1 Any extension, concession, waiver or relaxation of any action stated in this contract by the Parties, the *Service Manager* or the *Adjudicator* does not constitute a waiver of rights, and does not give rise to an estoppel unless the Parties agree otherwise and confirm such agreement in writing.

Z6 Health, safety and the environment: Add to core clause 27.4

- Z6.1 The *Contractor* undertakes to take all reasonable precautions to maintain the health and safety of persons in and about the execution of the *service*. Without limitation the *Contractor*:
- accepts that the *Employer* may appoint him as the “Principal Contractor” (as defined and provided for under the Construction Regulations 2014 (promulgated under the Occupational Health & Safety Act 85 of 1993) (“the Construction Regulations”) for the Affected Property;
 - warrants that the total of the Prices as at the Contract Date includes a sufficient amount for proper compliance with the Construction Regulations, all applicable health & safety laws and regulations and the health and safety rules, guidelines and procedures provided for in this contract and generally for the proper maintenance of health & safety in and about the execution of the *service*; and
 - undertakes, in and about the execution of the *service*, to comply with the Construction Regulations and with all applicable health & safety laws and regulations and rules, guidelines and procedures otherwise provided for under this contract and ensures that his Subcontractors, employees and others under the *Contractor’s* direction and control, likewise observe and comply with the foregoing.
- Z6.2 The *Contractor*, in and about the execution of the *service*, complies with all applicable environmental laws and regulations and rules, guidelines and procedures otherwise provided for under this contract and ensures that his Subcontractors, employees and others under the *Contractor’s* direction and control, likewise observe and comply with the foregoing.

Z7 Provision of a Tax Invoice and interest. Add to core clause 51

- Z7.1 Within one week of receiving a payment certificate from the *Service Manager* in terms of core clause 51.1, the *Contractor* provides the *Employer* with a tax invoice in accordance with the *Employer’s* procedures stated in the Service Information, showing the amount due for payment equal to that stated in the payment certificate.
- Z7.2 If the *Contractor* does not provide a tax invoice in the form and by the time required by this contract, the time by when the *Employer* is to make a payment is extended by a period equal in time to the delayed submission of the correct tax invoice. Interest due by the *Employer* in terms of core clause 51.2 is then calculated from the delayed date by when payment is to be made.
- Z7.3 The *Contractor* (if registered in South Africa in terms of the companies Act) is required to comply with the requirements of the Value Added Tax Act, no 89 of 1991 (as amended) and to include the *Employer’s* VAT number 4740101508 on each invoice he submits for payment.

Z8 Notifying compensation events

- Z8.1 Delete the last paragraph of core clause 61.3 and replace with:
- If the *Contractor* does not notify a compensation event within eight weeks of becoming aware of the event, he is not entitled to a change in the Prices.

Z9 Employer’s limitation of liability

- Z9.1 The *Employer’s* liability to the *Contractor* for the *Contractor’s* indirect or consequential loss is limited to R0.00 (zero Rand)
- Z9.2 The *Contractor’s* entitlement under the indemnity in 82.1 is provided for in 60.1(12) and the *Employer’s* liability under the indemnity is limited to compensation as provided for in core clause 63 and X19.11 if Option X19 Task Order applies to this contract.

Z10 Termination: Add to core clause 91.1, at the second main bullet point, fourth sub-bullet

point, after the words "against it":

Z10.1 or had a business rescue order granted against it.

Z11 Ethics

For the purposes of this Z-clause, the following definitions apply:

Affected Party means, as the context requires, any party, irrespective of whether it is the *Contractor* or a third party, such party's employees, agents, or Subcontractors or Subcontractor's employees, or any one or more of all of these parties' relatives or friends,

Coercive Action means to harm or threaten to harm, directly or indirectly, an Affected Party or the property of an Affected Party, or to otherwise influence or attempt to influence an Affected Party to act unlawfully or illegally,

Collusive Action means where two or more parties co-operate to achieve an unlawful or illegal purpose, including to influence an Affected Party to act unlawfully or illegally,

Committing Party means, as the context requires, the *Contractor*, or any member thereof in the case of a joint venture, or its employees, agents, or Subcontractors or the Subcontractor's employees,

Corrupt Action means the offering, giving, taking, or soliciting, directly or indirectly, of a good or service to unlawfully or illegally influence the actions of an Affected Party,

Fraudulent Action means any unlawfully or illegally intentional act or omission that misleads, or attempts to mislead, an Affected Party, in order to obtain a financial or other benefit or to avoid an obligation or incurring an obligation,

Obstructive Action means a Committing Party unlawfully or illegally destroying, falsifying, altering or concealing information or making false statements to materially impede an investigation into allegations of Prohibited Action, and

Prohibited Action means any one or more of a Coercive Action, Collusive Action Corrupt Action, Fraudulent Action or Obstructive Action.

Z11.1 A Committing Party may not take any Prohibited Action during the course of the procurement of this contract or in execution thereof.

Z11.2 The *Employer* may terminate the *Contractor's* obligation to Provide the Services if a Committing Party has taken such Prohibited Action and the *Contractor* did not take timely and appropriate action to prevent or remedy the situation, without limiting any other rights or remedies the *Employer* has. It is not required that the Committing Party had to have been found guilty, in court or in any other similar process, of such Prohibited Action before the *Employer* can terminate the *Contractor's* obligation to Provide the Services for this reason.

Z11.3 If the *Employer* terminates the *Contractor's* obligation to Provide the Services for this reason, the amounts due on termination are those intended in core clauses 92.1 and 92.2.

Z11.4 A Committing Party co-operates fully with any investigation pursuant to alleged Prohibited Action. Where the *Employer* does not have a contractual bond with the Committing Party, the *Contractor* ensures that the Committing Party co-operates fully with an investigation.

Z12 Insurance

Z 12 .1 Replace core clause 83 with the following:

Function of the Price List

Clause 54.1 in Option A states: "Information in the Price List is not Service Information". This confirms that instructions to do work or how it is to be done are not included in the Price List but in the Service Information. This is further confirmed by Clause 20.1 which states, "The *Contractor* Provides the Service in accordance with the Service Information". Hence the *Contractor* does **not** Provide the Service in accordance with the Price List. The Price List is only a pricing document.

Link to the *Contractor's* plan

Clause 21.4 states "The *Contractor* provides information which shows how each item description on the Price List relates to the operations on each plan which he submits for acceptance". Hence when compiling the *price list*, the tendering contractor needs to develop his first clause 21.2 plan in such a way that operations shown on it can be priced in the *price list* and result in a satisfactory cash flow in terms of clause 11.2(17).

Preparing the *price list*

Before preparing the *price list*, both the *Employer* and tendering contractors should read the TSC3 Guidance Notes pages 14 and 15. In an Option A contract, either Party may have entered items into the *price list* either as a process of offer and acceptance (tendering) or by negotiation depending on the nature of the service to be provided. Alternatively the *Employer*, in his Instructions to Tenderers or in a Tender Schedule, may have listed some items that he requires the *Contractor* to include in the *price list* to be prepared and priced by him.

It is assumed that in preparing or finalising the *price list* the *Contractor*:

1. Description of the service

1.1 Executive overview

Lethabo Power Station employs trained maintenance personnel to execute maintenance activities on various plant areas. Due to a lack of support from Eskom Academy of Learning (EAL) a decision was made to source a service provider to provide Electrical Training to Lethabo Learner Artisans and Learner Technicians. The intention is to acquire a complete Electrical Maintenance Training Contract with a service provider who shall be responsible and accountable for the successful training of Lethabo Power Station's learner Artisans and learner Technicians as well as for the preparation of artisan for trade test.

1.2 Employer's requirements for the service

The appointed contractor/service provider shall be well resourced, certified, experienced, and registered as a training facilitator/assessor. The training facility or venue where the training will be provided shall be accredited with SETA in order to be able to provide the Electrical training to Lethabo Power Station's learner Artisans and learner Technicians. The contractor shall provide course facilitation, carry out assessment and provide an advisory service in line with Eskom guidelines and requirements.

The suitable contractor/service provider shall provide maintenance training services to Eskom Generation Lethabo Power Station over a period of five (5) years covering:

- Electrical Artisan training.
- Electrical Technician training.
- Electrical specific gap closing training and advance training.

The activities include:

a. COURSE FACILITATION

- Conducting the training needs using available business processes such as communicating with clients through Eskom agent.
- Planning for delivery of the courses as per the needs.
- Submitting the training plans for influence by end users through Eskom agent.
- Submitting the plans for scheduling in line with the Eskom Learning Management System.
- Preparing the applicable logistics viz training venue, training aids, learning materials, attendance register and code of conduct.
- Confirming the course bookings
- Presenting the course using the available, applicable, and relevant latest technology
- Supporting the learners in the retention of the knowledge through facilitating of group discussions and self-assessment
- Monitoring if the training time is used optimally.
- Submitting the presentation sessions for evaluation in line with Eskom training procedures.

b. ASSESSMENT

- Compile the assessment tool as per Eskom assessment procedures.
- Preparing sufficient copies for the delegates.
- Preparing the appropriate venue for the assessment.
- Preparing the Learners for Trade Test.
- Invigilating the assessment sessions and address deviations as per the Eskom disciplinary procedures through Eskom agent.
- Marking the answer sheets in line with SETA's code of conduct and Eskom assessment procedure.

- Submitting the answer sheets for internal moderation as per Eskom Moderation procedures.
- Compiling the training results for moderation, Eskom agent information and capturing into the Eskom Learning Management System.
- Updating the relevant documents for training reports to stakeholders through Eskom agent.
- Compiling the training reports as per the Eskom Procedures and local requirements.

c. OTHER SERVICES

- Preparing delegates for assessment rewrite as per the Eskom procedures
- Compiling the assessment rewrite tools for the delegates following the Eskom and local procedures.
- Preparing logistics for the rewrites of the assessment and following all assessment scope of work stated above.
- Providing the advisory services as and when required.
- Keeping the training records to avail to stakeholders as required.

2. Management strategy and start up.

2.1 The *Contractor's* plan for the service

The contractor/service provider shall present the training program/schedule for the Electrical Training for Lethabo learner Artisans (Apprenticeships) and Technicians to the project / contract manager. The Contractor / service provider to provide the project / contract manager with the following:

- Starting and the end date of the *service period*.
- Order and timing of the Work of the *Employer*
- Provisions for: - time risk allowances, health and safety requirements.
- Access to the Site/Affected Property as stated in the Service Information
- Acceptances.
- A statement of how the *Contractor* plans to provide the Electrical Training Services identifying the Equipment and other resources which he/she plans to use. The service provider shall ensure that that the personnel providing the training services are trained and certified.
- Location of the training facility as well as proof of accreditation.
- The SAQCC certification for each personnel performing or providing the services shall be valid for the duration of the contract.
- Other information which the Service Information requires the *Contractor* to show on a plan submitted for acceptance.

The contractor/service provider shall report directly to the Contracts Manager. The Contracts Manager shall inform the contractor/service provider as to when the services is expected to start.

2.2 Management meetings

Meetings of a general nature may be convened when required and chaired by the *Supply Manager* as follows:

Meetings of a specialist nature may be convened as specified elsewhere in this Service Information or if not so specified by persons and at times and locations to suit the Parties, the nature and the progress of the *service*. Records of these meetings shall be submitted to the *Service Manager* by the person convening the meeting within five days of the meeting.

All meetings shall be recorded using minutes or a register prepared and circulated by the person who convened the meeting. Such minutes or register shall not be used for the purpose of confirming actions or instructions under the contract as these shall be done separately by the person identified in the *conditions of contract* to carry out such actions or instructions

2.3 *Contractor's* management, supervision, and key people

The *Contractor* shall provide the services at the premises of the service provider's approved and accredited training facility or at any other approved and accredited training facility as discussed and agreed upon by the Contracts Manager and the service provider. The Contractor to provide a key list of personnel who will carry out the training services. The key personnel executing the training services shall be qualified, trained, accredited, and certified. The SAQCC certification for each personnel providing the services shall be valid for the duration of the contract. A company organogram will be needed by the Service Manager to communicate accordingly to comply with the NEC 3 Term Services Contract communication structures.

2.4 Documentation control

Each instruction, certificate, submission, proposal, record, acceptance, notification, reply and other communication which this contract requires is communicated in a form which can be read, copied, and recorded. Writing is in the language of this contract. Assessment supporting documentation to be handed to the Employer / Service Manager (to be announced by the Employer). All communications must be printed and filed in the Service Managers file.

All training courses shall have a formal assessment at the end of the training to determine the learner Artisans (Apprenticeships) and Learner Technicians competence. Attendance register for all training must include name, contact number, and physical address of the learner Artisans (Apprenticeships) and Learner Technicians. The pass mark is 80%. In the event the Learner Artisans (Apprenticeships) and Learner Technicians obtains less than 80%, a re-write will be required. A Certificate shall be awarded to the learner Artisans (Apprenticeships) and Learner Technicians only if the Learner achieves 80% and higher.

2.5 Invoicing and payment

The contractor/service provider shall present all artisan and technician classroom training as well as all artisan and technician practical training using the latest available, applicable, and relevant technologies.

2.9 Management of work done by Task Order

A Task is work within the service which the *Service Manager* may instruct the *Contractor* to carry out within a stated period.

A signed Task Order is the *Service Manager's* instruction to carry out a Task.

Task Completion is when the *Contractor* has done all the work in the Task and corrected Defects which would have prevented the *Employer* or Others from using the Affected Property and Others from doing their work.

Task Completion Date is the date for completion stated in the Task Order unless later changed in accordance with this contract.

A Task Order includes:

- A detailed description of the work in the Task.
- A priced list of items of work in the Task in which items taken from the Price List are identified.
- The starting and completion dates for the Task.
- Conditions of the *service agreement* is in accordance with the Task Order issued.
- A CDSS should be submitted with each Task Order.

The *Service Manager* consults the *Contractor* about the contents of a Task Order before he issues it.

The Prices for items in the Task price list which are not taken from the Price List are assessed in the same way as compensation events.

No Task Order is issued after the end of the service period.

Work will not commence on site without the *Contractor* receiving a signed detailed task order that has been agreed upon by the *Service Manager* and the *Contractor*.

It is the Contractors responsibility to provide the *Service Manager* a detailed Task Order programme for acceptance within the period stated in the Contract Data.

Only when the Task Order programme is accepted and agreed upon by the *Service Manager* and the *Contractor* will any work commence.

- Service Provider shall demonstrate compliance with the Act, Eskom Safety Standards and Specifications Act:
 - Occupational Health and Safety Act of 1993
 - Standard 32-136: Standard Contractor Health and Safety Requirements.

- Overall compliance to LBS00067PC - Health, Safety and Environmental Specification for Contractors, Contractor Health and Safety Requirements 32-136, Strict compliance to Occupational Health and Safety Act No 85 of 1993 and, Regulations (As Amended).

The *Contractor* shall comply with the health and safety requirements contained in Annexure _____ to this Service Information.

3.2 Environmental constraints and management

No Environmental Impact Assessment required; however, the service provider is to ensure compliance to environmental requirements of ISO14001. Lethabo environmental procedures will be provided with tender documents.

The *Contractor* shall comply with the environmental criteria stated below:

3.3 Quality assurance requirements

The Contractor / Service provider shall ensure adherence to the following:

- Quality Management System: The Contractor shall be required to demonstrate by means of a Contract Quality Plan meeting the minimum requirements of ISO 10005, that this organisation is so structured that all the requirements of the specification will be properly monitored and controlled. The Quality Plan and Control procedures are to be carried out in accordance with QM 58.
- A recent certified copy of valid registration or other relevant category in relation to Scope of Work i.e. SETA Accreditation.
- The Supplier shall prepare and submit quality documentation as per the tender selected category (indicated in Form A) using the tender returnable document. By signature on Form A, The Contractor acknowledges and agrees to comply with and adhere to Eskom's policies and procedures (current and/or latest revisions) including the Supplier Contract Quality Requirement Specification (QM58). The Supplier further ensures that the outsourced product/service programmes conform to the requirements of the Works Information.
- Quality requirements categorisation: Category 3 - Quality Requirements to be met.
- Risk Management: The service provider to develop, implement and maintain Risk Management Plan/Risk Register detailing Contingency plan. List all Risks associated with delivering the scope of work, what actions would be taken to mitigate the identified Risks.
- Competence/Segregation of duties: The service provider to demonstrate with a documented Information on determining the knowledge, skill and competency required for the achieved conformity of products and services i.e. Facilitators and Moderators competency and appointment letters.
- Non-Conformance and Defects: NCR's and defects notifications are issued; the Service provider will acknowledge the receipt within 48 hours and proposes corrective and preventive actions to the client as per the contract response period. The corrective and preventive actions will include the implementation and completion dates

5 Working on the Affected Property

5.1 Employer's site entry and security control, permits, and site regulations

In the event the Contractor / Service provider or his delegate is required to be on site for a meeting or any other reason which is related to this contract, the following will apply,

- The Contractor applies for temporary access permits (Contractor's Permit) at the Security gate, prior to the Possession Date.
- The Contractor personnel are required to be always in possession of a Contractor's Permit.
- All Contractor personnel are issued with a temporary access permit (Contractor's Permit) which contains the following information: Name, ID Number, Company, Validity date.
- All Contractors' permits are submitted to Protective Services when leaving the site.
- To assist Protective Services with the issuing of permits, the Contractor supplies a list of all personnel that he intends using on site, at least 24 hours prior to entry of the Security Area.
- This list is delivered to Protective Services.
- The list, identified with the Contractor's name, contains the following information: Employee Name, Employee ID Number, Eskom Safety Co-ordinator signature, Eskom Employers Representative signature, Copy of the first page of the ID book of every employee of the Contractor,
- To speed up the process of gaining access to the site, the Contractor compiles detailed lists of all tools and equipment to be taken on site before arriving at the Power Station Security gate.
- An authorised copy of this list is retained to be used again when the tools and equipment is removed from site after the completion of the works.
- The Chief of Protective Services may, with valid cause, remove any of the Contractor's personnel from the site, either temporarily or permanently, without any prejudice. He may deny access to the site to any person whom, in the opinion of the said Chief of Protective Services, constitutes a security risk.
- Only Contractor's vehicles with displayed Contract Vehicle Permits disks are allowed on site.

Note: Five Life Saving Rules have been developed that will apply to all Eskom employees, agents, consultants, and contractors. All Eskom employees, agents, consultants, and contractors to comply with the following Eskom life Saving Rules:

Rule 1: Open, Isolate, Test, Earth, Bond, And / Or insulate before touch - that is any plant operating above 1 000 V.

Rule 2: Hook up at heights - no person may work at height where there is a risk of falling.

Rule 3: Buckle up – no person may drive any vehicle on Eskom business and/or on Eskom premises: unless the driver and all passengers are wearing seat belts.

Rule 4: Be sober (no person is allowed to work under the influence of drugs and alcohol.

Rule 5: Use a permit to work – where an authorization limitation exists, no person shall work without the required permit to work
