1. INTRODUCTION

The Atlantis Special Economic Zone (ASEZ) was officially designated in October 2018. The success of the ASEZ rests on strong collaboration across the public and private sector spectrum. The promulgation of the ASEZ was enabled through collaboration between the Department of Trade and Industry and Competition (DTIC) and Western Cape Government (WCG)'s Department of Economic Development and Tourism (DEDAT), Wesgro and the City of Cape Town (CoCT). Initially inspired by the City of Cape Town's Green Technology Manufacturing Hub, these parties are working together to facilitate the development of the SEZ in Atlantis.

The ASEZ is a keystone initiative that sits within the country's broader green economy industrial development strategy. It thus both supports and draws on these initiatives. Ultimately, Atlantis needs to operate as a viable industrial hub within a thriving green economy and contributing to green technology industrialization and job creation in South Africa. It is an important development intervention tool to unlock green industrial development, manufacturing, employment, technology development, enterprise development and skills development, amongst other opportunities expressed in the green sector strategies, policies and plans of government.

2. SPECIFICATION

Background

There is a focus within the ASEZ on localisation and job creation. This entails the capacitation of local community members and skills development for both employed and unemployed persons. There are multiple initiatives delivered by the ASEZ, with this specific project supporting the overall community development drive.

This specific project is outlined in the scope of work section and should provide the necessary information to develop an outcomes-based proposal. It is essential that the skills development sector, specifically linked to SETAs is understood, with a specific focus on learner development and capacitating community members. Furthermore, an aspect of local development included in the proposal, is suggested, and encouraged.

Skills development is a key priority for the ASEZ. We want to enable and equip local community members to access employment opportunities in the zone and this is only possibly through dedicated training opportunities.

Scope of Work:

The scope entails the training and development of CLOs in the area to ensure they understand their roles within the community. This would entail the engagement and incorporation of local community members, with focus on the development of skills sets in the area.

The following project deliverables have been identified for RFQ 002 / 2022 IES

The training of fifteen (15) Community Liaison Officers. The outcomes of the training are expected to be aligned with standard community development practices and expectations in relation to construction projects, which are:

- Understanding the role of the CLO between the community and the contractor.
- Liaising between the project holder, the community and the various contractors.
- The identification of local resources, the creation of a database and engagement with these resources.
- Keeping contractors and the project holder aware of community affairs and possible dynamics.
- How to assist the contractor's supervisory staff in the management of workers.
- Reporting to relevant stakeholders.
- Involvement in the targeting, training and the equity status of employees.
- Understanding and being involved in the administrative tasks related to implementation of projects.

Please note the service provider will have to provide catering, venue and the materials required for the training. This must be included in the quotation. Their duties will also include providing information, translation, or training to people in the community, CLOs may also host or attend community meeting.

Duration.

- The duration of the contract is dependent on the length of the actual courses proposed, bearing in mind that these need to be credit-bearing courses. However, the contract duration will not extend more than 1 year, 12 calendar months.

9. CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
