1. INTRODUCTION AND PURPOSE

To appoint a service provider for the supply of the following:

A. Fibre Glass, 9M, 22Kv link stick. Round complete with hook and bag.

Calibration certificate must be provided.

B. Stepladder extension fibre glass 9,6m. Test certificate must be provided.

C. Reticulation set 22KV complete with 4 jumper cables. Test certificate must be provided.

It is very dangerous for the personnel to work on the 11 000 volt overhead lines without a link stick and reticulation set

the electricians will use the Link stick to do switching and replace Mv fuses on up

to 22Kv conductor lines. The electrician can do all switching live. It will not be necessary for an electrician to switch off the 11 000 v lines to open a section.

The electrician can use the link

stick while he/she is standing on the ground to do work on the Mv lines. The reticulation must be used to bridge all phases and lamp lines with the neutral and the earth ground.

If the reticulation sets are hooked on the overhead lines and all phases with earth and neutral are bridged the special worker is allowed to use his stepladder to work on the overhead lines. We need stepladders for the personnel to work on the overhead lines.

- The aim and objectives of the project to supply the electrician with a link stick, reticulation set and stepladders to work safe on the 11000volt overhead line. To prevent any injuries or dead.
