### **PROPOSALS:**

Proposals for educational or housing developments however should not be submitted as they are competencies of provincial/national Governments.

### **GRANTS**

Applications for grants funding are also invited which must be made on the official application form available at the Subcouncil 21 Office, with a letterhead and include the following details:

- date established
- type of organization (NPO, section 21 company, schools, sport bodies, community organisation)
- details of previous funding by the city
- Details of other funding for the current financial year received from the City
- purpose or aim of grant
- detailed description of project to be implemented utilising the funding
- Detailed breakdown of project costs'
- Proposals for funding submitted must be based on the City of cape Town's strategic focus areas and objectives which are: An opportunity City, A Safe city, A Caring City, An Inclusive City and A Well run City.
