- The successful bidder will have to collect and return the Truck (DVS 430 EC) at the Municipal workshop in Jeffreys bay.
- Bidder to repair all body panels, repaint and brand.

#### Refurbishing of all body parts and panel beating according to SANS 1391

#### **Body repairs:**

#### Truck Cab, chassis and tank unit repairs.

- High pressure cleans the entire chassis and spray paint with at least two coats of black edge primer and finish off with chassis black.
- Remove all rust from the truck cab and repaint with two coats of primer.
- Paint the entire truck and load bin with 2k fire engine red paint, at least two coats.
- Re-spray all six rims with 2 K black paint.
- Fit reflective yellow stripes and three [3] amber reflectors on the left- and right-hand side of vehicle, five [5] red reflectors on the rear and two white reflectors on front.
- All steps gaining access to cab to be repaired.
- Entire cab of vehicle to be vale cleaned on the inside.
- New mudflaps to be fitted to the truck all-round.
- All damaged door rubbers to be replaced with new rubbers.
- New floor rubbers to be fitted to the truck.
- Four locker doors to be repaired.
- Left- and right-hand side of the vehicle tank unit to be repaired.
- Left- and right-hand deck lockers to be repaired.
- Left- and right-hand rear mudguards to be cut out and new mudguards to be manufactured.
- New mirror brackets must be manufactured and installed onto the vehicle.
