CONSTRUCTION OF AN EARLY CHILDHOOD DEVELOPMENT CENTRE AT GABANGEMFUNDO PRIMARY SCHOOL AT UTHUKELA DISTRICT, KWAZULU-NATAL

The Coega Development Corporation (CDC) is headquartered in the City of Gqeberha, Nelson Mandela Bay Municipality, South Africa, with a strategic operational footprint in South Africa and beyond the borders in the African continent. The CDC's vision is to be the leading catalyst for the championing of socio-economic development. This it seeks to achieve through the development and operation of the 9 003 hectare Coega Special Economic Zone (SEZ), a transshipment hub and a leading investment destination in Africa, providing highly skilled competence and capacity for the execution of quality complex infrastructure and related projects throughout South Africa and selected markets on the African continent, and advisory on the development of industrialization and logistics zones. The CDC's advanced capabilities are successful enablers in economic zone development and management, real assets management, infrastructure planning and development for National, Provincial, Local Government Departments and State-owned Entities, technology integration while realising related socio-economic impact areas such as skills and SMME development. The foundational culture of the CDC's approach, backed by core values, is innovation and continuous improvement.

The CDC has been appointed by the Department of Education, KwaZulu Natal Province (DoE) to assist with the implementation of the Early Childhood Development programme.

INVITATION AND SCOPE OF SERVICES

The CDC is inviting capable and competent Contractors with an active CIDB grading of **5GB or higher**, potential emerging bidders of **4GB PE** will not be eligible to bid for the construction of an ECD at Gabangemfundo Primary School, uThukela District, KwaZulu-Natal.

The scope of work is as follows:

- (a) Construction of new 5No. Grade-R Classroom block including covered walkways / verandah
- (b) Construction of new Grade-R VIP Ablution block – 5No. Seater WC and 1No. Paraplegic Seater WC with 4No. WHB
- (c) Construction of new 2No. covered play areas
- (d) Installation of fencing and pedestrian gate along the perimeter of the ECD Centre
- (e) Jungle Gym, Joy Wheels, Swings and Sand Pit
- (f) New Covered walkway between Grade-R classroom block and Grade-R ablution block
- (g) Uncovered concrete walkway from the existing building to the new ECD Centre classroom block
- (h) New concrete v-drains around the new blocks
- (i) 3No. New rainwater harvesting tanks including tank stands
- (j) Construction of a soakaway including sewer drainage
- (k) Removal of school bins and rock formations
- (l) Installation of new ECD Centre Signage
- (m) Stormwater drainage
- (n) Bulk Earthworks
- (o) Grassing

The contract period shall be **seven (7) calendar** months from date of handover of site, including annual builders' holidays.

CONDITIONS OF TENDER

- (a) Bidders shall be registered with the Construction Industry Development Board (CIDB) and should have a minimum active CIDB Contractor grading of **5GB or higher** potential emerging contractors with **4GB PE CIDB grading are** not eligible to make submissions and will not be considered.
- (b) The CDC's Procurement Policy and Procedures shall apply.
- (c) The following legislation shall apply:
 - (i) Public Finance Management Act (PFMA).
 - (ii) Preferential Procurement Policy Framework Act, 2000
 - (iii) The Preferential Procurement Regulations 2017
 - (iv) The CIDB Act 38 of 2000
 - (v) National Treasury Regulations.
 - (vi) Occupational Health and Safety Act and Regulations, Act (85 of 1993).
 - (vii) Compensation for Occupational injuries and disease Act (130 of 1993).
 - (viii) BBBEE Act Number 53 of 2003 (as amended by Act number 46 of 2013); and
 - (ix) Any other applicable legislation.

- (d) The 80/20 preference point system, as per the Preferential Procurement Policy Framework Act 2000. The allocation of points - will apply as follows:
- (i) Price - 80
 - (ii) BBBEE Status - 20
- (e) Bidders and all its Consortium/Joint Venture (JV) members, if any, must confirm their company registration with Companies and Intellectual Property Commission (CIPC) (formerly CIPRO) as CDC will not award any bid to any business that appears on the CIPC List of de-registered businesses. The CDC may verify company registration with CIPC through BizPortal
- (f) All Bidders must be Value Added Tax (VAT) Vendors and the Form of Offer must include VAT.
- (g) Bidders (All the members in the Bidding Team in the case of Consortia or Joint Ventures) must provide proof of registration on the National Treasury's Central Supplier Database (CSD) or provide a Treasury CSD registration number e.g. MAAA0
- (h) The CDC will only award the Bid to a Successful Bidder who is tax compliant. The tax compliant status of the Bidders (and all the members in the Bidding Team in the case of Consortia or Joint Ventures) will be verified through the CSD and South African Revenue Services (SARS) website.
- (i) Bidders with a CIDB grading of 7 GB or higher must complete and signed FORM K: SMME Target Form (Main Contractor to meet 33% SMME/EME participation of tender value, excluding VAT, escalation, and socio-economic deliverables.
- (j) As per amended construction codes, companies with less than 51% black shareholding (QSEs & Generics) are to submit a valid SANAS Accredited B-BBEE Verification Certificate (with the full applicable B-BBEE elements) QSE with at least 51% or 100% black shareholding and EMEs with an annual turnover of R 3 million are required to submit a B-BBEE verification certificate from a SANAS accredited verification agency as they have to comply with the 30% sub-minimum requirement on the QSE Skills Scorecard to avoid being discounted a level. EMEs with a turnover of less than R 3 million are exempt from complying with the subminimum requirement and may submit an affidavit or a certificate issued by CIPC, confirming their ownership and annual turnover.
- (k) In case of a Joint Venture (JV) / Consortium, a consolidated B-BBEE certificate would be required, and it must be accompanied by individual B-BBEE Certificates/affidavits of their entities to confirm the type of enterprise.
- (l) Bidders must complete and sign the POPI Act form. In case of Joint Venture/ Consortium, a separate form in respect of each party to the JV must be completed.

- (m) CDC will not award more than two active projects to one bidder, unless one project has reached 80% completion stage and beyond. Capacity assessment may be conducted in an event that the recommended bidder is the only responsive service provider and has already been awarded two contracts.
- (n) Public servants are prohibited from conducting any form of business with organs of state, whether in their own capacity as individuals or through companies in which they are directors. Verification will be done, and bidders will be disqualified should they be found to be in contravention with the regulations. A letter of confirmation must be provided with this bid document should a bidder have been granted permission by National Treasury to conduct business with an organ of state; and
- (o) The successful bidder will be required to comply with the Occupational Health and Safety Act and Regulations, Act (85 of 1993) and Compensation for Occupational injuries and disease Act, Act (130 of 1993) and all relevant and applicable legislations. Upon appointment of the successful bidder, the service provider will be required to develop Occupational Health, Safety and Environmental Management Systems to comply with the SANS Norms and Standards. CDC SHEQ Unit will monitor compliance and implementation of Occupation Health and Safety, Environmental and Quality requirements for the duration of the contract.
- (p) A successful Bidder will be required to provide valid proof of registered Construction Health and Safety Officer/Manager (CHSO/M) with SACPCMP upon award. No candidate registration will be accepted. The CHSO/M must have proven record of minimum **of three (3) years'** experience or more.
- (q) Bidders are required to meet the minimum stipulated threshold for Local Production and Content as per **SBD6.2** in the tender document. Bidders to ensure that they submit a completed and signed SBD 6.2 Form and SATS 1286:2011, Annexure C. The stipulated minimum threshold(s) for local production and content (refer to Annex A of SBD 6.2) for this bid is/are as follows:
- (i) Steel Value added products - 100% Stipulated minimum threshold
 - (ii) Electrical and Telecoms Cables - 90% Stipulated minimum threshold
 - (iii) Plastic Pipes - 100% Stipulated minimum threshold
 - (iv) Textile, Clothing and Leather Footwear– 100% Stipulated minimum threshold
 - (v) All Cement Products – 100% Stipulated minimum threshold
- (r) No telephonic or any other form of communication with any other CDC member of staff, other Procurement representative, relating to this request for tender will be permitted.
