Cape Agulhas Municipality is currently awaiting tenders for the Supply & Installation of Air Conditioners at Municipal Offices, Bredasdorp.

A tender participation fee of R300 is payable for each set of documents issued. A compulsory clarification meeting will be held on **03 August 2022 at 10H00, at the Community Services Building, Committee Room, 1 Dirkie Uys Street, Bredasdorp**. Bidders that fail to attend the compulsory clarification meeting will be disqualified. A representative may only represent one tenderer at this meeting.

It is estimated that contractors should have a CIDB grading of **1 ME or higher**.

Sealed quotations marked "**Quotation Nr: Q6/202/23 SUPPLY & INSTALLATION OF AIR CONDITIONERS AT MUNICIPAL OFFICES, BREDASDORP**", must be placed in the tender box at the Municipal Offices, 1 Dirkie Uys Street, Bredasdorp or posted to reach the Municipal Manager, Cape Agulhas Municipality, PO Box 51, Bredasdorp, 7280 not later than **12:00 on Friday, 12 August 2022** after which it will be opened in public. Tenders may only be submitted on the prescribed official document.

The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders. The **two-stage bidding** process will be followed in evaluating this tender. Firstly, it will be evaluated in terms of the stipulated minimum threshold for local production and content and thereafter for price and preference point system.

A Tax Compliance status pin as issued by the South African Revenue Service, must be submitted together with the bid.

Council reserves the right not to accept the lowest or any tender. No faxes or e-mails will be accepted.
