2. DESCRIPTION OF THE NEED / SCOPE OF WORK

NRWDI intends to procure full-size hygiene packs for **100 primary school learners** in the Kamiesberg area to promote dignity, hygiene, and learner well-being.

In addition, quarterly sanitary towel support will be provided to **50 identified girl learners** for a full calendar year.

All items must be standard retail size (not travel-size), sealed, good quality, and suitable for primary school learners.

2.1 Hygiene Pack Contents (Per Learner – Full Retail Size) Quantity required: 100 hygiene packs

Each hygiene pack must include:

- 2.1.3.1 Toothbrush (adult size, individually packaged)
- 2.1.3.2 Toothpaste (minimum 100ml tube)

2.2 Sanitary Towels (50 Girl Learners – Quarterly Provision)

Specification per learner per quarter:

- 3 packs of 10 sanitary pads per learner per quarter
- Total annual provision: 4 quarterly deliveries
- Delivery schedule to be agreed with NRWDI

All sanitary products must be retail quality, sealed, and suitable for school use.

2.4 Delivery Requirements

The hygiene packs must be delivered in **Springbok, Northern Cape Province** from **18 March 2026**.

3. EVALUATION CRITERIA

3.1 Mandatory Requirement (At RFQ Closing Date)

- 3.1.1 Suppliers who fail to quote fully or according to the specification and scope of work will be disqualified.
- 3.1.2 Quotations submitted after the RFQ closing date and time will be disqualified.
- 3.1.3 Quotations that are not sent through the procurement central email will not be considered for evaluation.
- 3.1.4 Submit at least two (2) reference/recommendation letters from previous clients where hygiene items were supplied in bulk (+50 upwards). The letters must be on the letterhead of the previous clients, with contact details.

- 3.2.1 Non tax compliant Bidders will not be awarded the RFQ.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“black people”** is a generic term which means Africans, Coloureds and Indians—
