SCOPE OF WORK/SPECIFICATIONS/ REQUIREMENTS:

SPECIFICATION FOR WORKMEN'S COMPENSATION ADMINISTRATION SERVICE PROVIDER

1. PURPOSE

To seek the service provider who will administer Workmen's Compensation as per Compensation for Occupational Diseases and Injuries Act.

2. BACKGROUND

Worker's compensation or what is commonly referred to as COIDA cover, is a compulsory assurance that is taken out, by a company, to cover their employees in the unlikely event that they are injured or contract diseases while performing their daily work duties. Worker's compensation cover is prescribed by the Compensation for Occupational Injuries and Diseases Act 130 of 1993. Accidents that arise out of and during employment resulting in personal injury or illness; occupational diseases contracted in the workplace; and fatalities because of an accident that happens on duty are typically covered by this assurance. Section 1 of the COID Act defines an "accident" as an accident arising out of and in the course of an employee's employment and resulting in a personal injury, illness or the death of the employee.

3. DISCUSSION

Umgeni Water is looking for a service provider to partner with in terms of providing administration of workmen's compensation in line with Compensation for Occupational Injuries and Diseases Act. The Act requires employers to report all accidents occur in the workplace and report all diseases that are caused by certain working conditions. The preferred service provider will perform the following functions:

- Reporting of accident claims and occupational diseases to the Compensation Fund.
- Liaise with Doctors/Hospitals to obtain medical reports and process accounts.
- Liaise with the Compensation fund to speed up claims.
- Assist in the application for Certificate of Good Standing as and when required.
- Obtain Claims Cost Summary annually.
- Submission of return of earnings and pay correct assessments;
- Provision of easy access to online assessments;
- Ensure payment of the correct tariff by ensuring that all sites are correctly classified;
- Restructuring of assessments where applicable; and
- Monitor claims costs and reduce tariffs where applicable.

4. CONTRACT TERM

The anticipated contract term is for a period of three years from the date of awarding.

5. **PRICING**:

- a) The tenderer's price must be fully inclusive and each item must be clearly specified.
- b) All additional costs must be clearly specified and included in the total quotation price, (e.g. transport, labour, etc.).
- c) All prices must be VAT inclusive.
- d) The tenderer's is responsible for all the cost that they shall incur related to the preparation and submission of the quotation.
- e) The validity period of the quotation is 90 days.
- f) The service providers shall provide prices (VAT exclusive) for ALL items listed in the table. Failure to provide prices in any of the items listed will deem this tender to be non-responsive.

6. PRICE INCREASES

Price must remain firm for a 12 month period and thereafter, will be subject to CPI escalation on the anniversary of the contract. A 30 day notice period prior to price increases is required.

 - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution.
