T1.1 TENDER NOTICE AND INVITATION TO TENDER (Incorporating SBD1)

The South African National Roads Agency SOC Limited (SANRAL) invites tenders Repairs to B3018 Nandi Drive Interchange Southbound Onramp over Umhlangane River on National Route 2, Section 25, km 25.. This project is in the province of KwaZulu-Natal in the district municipality of eThekweni and local municipality of eThekweni. The approximate duration is 2 months.

CIDB Regulation 25(1B) will not be applicable to this contract.

Only tenderers with a B-BBEE contributor status level of 1 or 2 and who is an EME and who are registered on the National Treasury Central Supplier Database and meet the minimum threshold designated for local production and content as stated in the Tender Data C.2.1, are eligible to tender.

It is estimated that tenderers should have a CIDB contractor grading designation of 4CE or higher, however tenderers attention is drawn to clause C.2.1 of the Tender Data when submitting their tender.

Tenders from tenderers registered as potentially emerging enterprises but with a CIDB contractor grading designation lower than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25(7A) of the Construction Industry Development Regulations, will not be accepted.
