Bids will be evaluated in accordance with the Preferential Procurement Regulations, 2017 and the attached specifications. The 80/20-preference point system will be used for the evaluation of the contract.

For bidders to qualify for the advantages of the B-BBEE Act, they must thoroughly complete the attached Annexure MBD 6.1. **There will be no benefits if the schedule is not thoroughly completed. Preference points MUST also be claimed in paragraph 6.1.** Bidders are required to submit **original and valid B-BBEE Status Level Verification Certificates or certified copies** thereof together with their bids, to substantiate their B-BBEE rating claims. This Bid is subject to the General Conditions of Tender and if applicable, any other Special Conditions of Tender. Swartland Municipality is not obliged to accept the lowest, any part of a bid or a bid.
