### Specification for Laptop Carry Bags

Only locally produced goods or services that meet the minimum threshold of 100% stipulated on MBD 6.2 for local production and content as determined by dti will be considered for acceptance. Any tender that does not meet the minimum threshold is an unacceptable tender. **ANY TENDERER THAT FAILS TO MEET THE LOCAL PRODUCTION AND CONTENT AS CONDITION OF TENDER REQUIREMENTS WILL BE DEEMED INVALID.** Tender Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System. Stage One being Functionality and Stage Two based on the 80/20 Preferential Point System in accordance with the Preferential Procurement Framework Act Regulations 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000. Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates which is accredited by SANS or certified copies of sworn affidavit thereof together with their bids, to substantiate their B-BBEE rating claims. Failure to submit the proof of B-BBEE Certificate or sworn affidavit will result in forfeiting the points. Valid Tax compliant status, Proof of registration on central supplier database and company registration certificate must be submitted together with the tender document. Service Provider must be registered on Municipality's Database. Tender documents will be available at Emadlangeni Municipality cashier's desk at a non-refundable fee at 34 Voor Street, Utrecht, 2980. Completed bid documents in sealed envelopes must be deposited in the Municipality's tender box located at the reception of the municipality on or before the closing date at **12h00 pm**, whereby bids will be opened to the public.
