## **1. PURPOSE**

KZN Growth Fund Agency (KZNGFA) is inviting suitably qualified and experienced service providers to supply, install and configure an advanced audio-visual system for three (3) boardrooms. The system should be capable of supporting high-quality video conferencing, presentations, hybrid meetings and seamless integration with Microsoft Teams.

## **2. BACKGROUND**

Kwazulu-Natal Growth Fund Agency (KZNGFA) is an Agency, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KZNGFA is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

### **2.1 Procurement Philosophy**
