1. INTRODUCTION

Technology Innovation Agency (TIA) an entity of the Department of Science, Technology and Innovation (DSTI) was established in terms of the TIA Act (Act No. 26 of 2008), with the objective to stimulate and intensify technological innovation in order to improve economic growth and the quality of life of all South Africans by developing and exploiting technological innovations, as the value chain depicted below. The Technology Innovation Agency makes use of the Hyland OnBase system for management of TIA investments.

2. PURPOSE

The objective of the request for quotation (RFQ) is to request all Hyland resellers to submit quotations for the renewal of TIA Hyland OnBase licenses for a period of 12 months.

3. SCOPE OF WORK

The successful bidder upon appointment will facilitate the renewal of the TIA Hyland OnBase licenses for a period of 12 months (see section 10.1 of this document for further details).

4. DURATION OF THE CONTRACT

The license agreement will Hyland will be for a period of 12 months.

8.1 The Respondent is responsible for all costs incurred in the preparation and submission of the quotes.

8.2 Kindly note that TIA is entitled to:

8.2.1 Amend any RFQ conditions, validity period, specifications, or extend the closing date and/or time of RFQs before the closing date. All Respondents, to whom the RFQ documents have been issued, will be advised in writing of such amendments in good time;

8.2.2 Verify any information contained in a proposal;

8.2.3 Not to appoint any bidder;

8.2.4 Vary, alter, and/or amend the terms of this RFQ, at any time prior to the finalisation of its adjudication hereof;

8.2.5 An omission to disclose material information, a factual inaccuracy, and/or a misrepresentation of fact may result in the disqualification of a proposal, or cancellation of any subsequent contract.

8.2.6 TIA reserves the right not to accept the lowest proposal or any proposal in part or in whole. TIA normally awards the contract to the Bidder who proves to be fully capable of handling the contract and whose Proposal is technically acceptable and/or financially advantageous to TIA. Appointment as a successful contractor shall be subject to the parties agreeing to mutually acceptable contractual terms and conditions. In the event of the parties failing to reach such agreement within process from the appointment date, TIA shall be entitled to appoint the contractor who was rated second, and so on.

8.2.7 TIA also reserves the right to award this RFQ as a whole or in part without furnishing reasons.

8.2.8 TIA also reserves the right to cancel or withdraw from this RFQ as a whole or in part without furnishing reasons and without attracting any liability.

8.2.9 The Bidder hereby offers to render all of the services described in the attached documents (if any) to TIA on the terms and conditions and in accordance with the



specifications stipulated in this RFQ documents (and which shall be taken as part of, and incorporated into, this proposal at the prices inserted therein).

8.2.10 The invoicing and payment will be made once the service has been executed.

8.2.11 This proposal and its acceptance shall be subject to the terms and conditions contained in this RFQ document.

8.3 TIA may disregard any submission if that bidder, or any of its directors:

8.3.1 Abused the Supply Chain Management (SCM) system of any Government Department / Institution.

8.3.2 Committed proven fraud or any other improper conduct in relation to such system.

8.3.3 Failed to perform on any previous contract and the proof thereof exists.

8.3.4 Restricted from doing business with the public sector if such a supplier obtained preferences fraudulently or if such supplier failed to perform on a contract based on specific goals.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
