#### 1. INTRODUCTION AND PURPOSE

In an era defined by digital connectivity and rising public expectations for transparency, the Communication, Marketing and Events (CME) Department is modernising its operational capabilities through the strategic procurement of high-performance equipment like all-in-one desktops and laptops, Ergonomic chairs and external drives amongst others. This investment will enable employees to work more effectively while maintaining the City's commitment to innovation, accountability, and inclusive service delivery. By equipping employees with reliable, cutting-edge technology, this initiative strengthens the department's ability to meet modern digital demands and foster greater civic engagement across Tshwane.

#### 2. BACKGROUND

The procurement of high-performance computing equipment for the City of Tshwane's Communication, Marketing and Events Department was driven by critical challenges identified through a 2022 Customer Satisfaction Survey and an internal capacity review. These assessments revealed that outdated ICT infrastructure has significantly hampered the municipality's ability to efficiently produce and disseminate professional digital content, despite growing resident demand for transparent, real-time updates on municipal services, council decisions, and community projects. This gap highlights the urgent need to upgrade the department's core computing systems to meet modern communication standards and enhance civic engagement.

Aligned with the City's Communication, Marketing and Events Policy, this initiative focuses on equipping staff with advanced equipment to amongst others, producing quality designs and streamline the creation of multimedia content—including livestreamed council meetings, high-resolution video edits, and multilingual public service

announcements. By prioritising reliable, high-speed processing power (such as the M4 Pro and M4 chips), the department will better document and promote key initiatives like infrastructure upgrades, utility maintenance programmes, and community projects. This upgrade directly supports strategic goals of accountability, inclusivity, and equitable information access, particularly for Tshwane's linguistically diverse population across its seven regions.

Key stakeholders, including City departments, political offices, municipal entities, and local media—will collaborate to ensure content reaches diverse audiences effectively. Direct beneficiaries include CME staff responsible for content creation and event coverage, while Tshwane's 3.3 million residents will benefit from improved access to timely updates, such as service disruptions or council meeting streams, in languages including isiZulu, Sepedi, and English.



#### 8. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the tenderer if they will be able to deliver on the price, if a tenderer confirm that they cannot, the tenderer will be disqualified based on being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

  - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
  - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
  - This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bidrigging.
  - In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:
