7. Upon acceptance of the Purchase Order, delivery will take place within stipulated timeframes as per the date of delivery indicated on the Purchase Order or within the date agreed with the DOT.

Vulnerability assessment service scope of work

Introduction

The Department of Transport (DoT) is in a process of rolling out a vulnerability management program. The program partly includes conducting a once-off vulnerability assessment exercise. The DoT therefore request interested service providers to submit quotations based on the provided requirements outlined below.

Assessment description

To conduct an internal and external vulnerability assessment.

Assessment goals

- a) To uncover and report on vulnerabilities that exist in the DoT IT systems with a goal to remediate identified risks.

Types of assessment to be performed

- a) The assessment should include both internal and external scanning that involves credential and non-credential scanning.
- b) The assessment should also include a combination of the following types of assessments:
 - Network assessment
 - Host assessment
 - Wireless assessment
 - Database assessment
 - Web applications assessment

Scope of service

- 1) The DoT network environment is distributed in three office locations, namely Pretoria, Centurion, and Capetown.
- 2) The scope covers +/- 700 desktops, 130 Windows and Linux hosts. 121 at Head office- Pretoria, 17 at SITA data center- Centurion and 2 in Capetown office. All hosts are virtualized using VMware VSphere platform.
- 3) The following below are key services running on hosts:
 - 2x Firewall and Firewall management server.
 - 1x Wireless access controller
 - 4x Windows domain controllers
 - 2x Novell eDirectory servers
 - 5x Mail server infrastructure
 - 5x SQL databases
 - 13x authenticated web facing portals
 - 1x VPN access infrastructure
 - 3x Web applications
 - 1x Website

- Comprehensive vulnerability assessment reports, remediation plans, and skills transfer.
