

Legal and Procedural Justification

The correction is made in accordance with the Department's obligation to ensure that all bid documentation reflects the correct application of preferential points as intended by the legislative framework. The original allocation inadvertently misrepresented the intended scoring matrix, which may have resulted in an inequitable evaluation of bids.

This amendment is issued to rectify the oversight and to ensure that all bidders are evaluated on a consistent and legally compliant basis.

Recommendations

The Department requests that:

- 1. The corrected Table 1 be formally adopted as an amendment to the bid documentation for Bid Number HEAL/228/25/MP.
- 2. All relevant stakeholders, including bid evaluation committees, be notified of the correction.
