13.2. SCOPE OF WORKS

1. INTRODUCTION

The Municipality intends to appoint a qualified and experienced Consulting Engineering Firm to provide **design, documentation, procurement support, contract administration, and construction supervision** services for **water and sanitation infrastructure projects** within its jurisdiction over a **three-year period**.

2. OBJECTIVE

To ensure the timely, cost-effective, and quality delivery of water and sanitation infrastructure through professional engineering design and construction supervision services that comply with national and municipal regulations, engineering standards, and sustainable practices.

3. SCOPE OF WORK
