



SPECIFICATION FOR THE FACILITATION OF GAAL STRATEGIC PLANNING SESSION.

1.INTRODUCTION.

Gateway Airport Authority Limited (GAAL) is a 3D scheduled public entity of the Limpopo Provincial Government, under the Limpopo Department of Transport and Community Safety (LDTCS). GAAL was established in March 1995 in terms of the Companies Act, 1973 (Act 61 of 1973) (Act 71 of 2008). It is GAAL's mandate to manage all non-private airports in Limpopo, including Polokwane International Airport, in compliance with various legislative and administrative acts such as the South African Civil Aviation Authority (SACAA) Act no 40 of 98.

GAAL Board and Management will be conducting a Strategic Planning session in preparation for the 2025/26 financial year on the 20 and 21 November 2025. The purpose of this Strategic session is to:

- Strengthen performance targets and indicators,
- Ensure alignment with the current strategic goals and fiscal realities
- Address current challenges and develop mitigating measures.

2.SCOPE OF WORK

- 2.1 The scope of work is to provide the following and not limited to:
 - Facilitation of the GAAL Strategic Planning sessions which is envisioned to start immediately upon appointment of the service provider in line with the pronouncement by the DPME on the new planning cycle and the Framework for Strategic Plans and Annual performance plans.
 - The service provider will be required to do research and groundwork and work hand-in hand with the Office of the CEO in the development of the necessary templates for the strategic planning session.





 The Executive Committee strategic planning session will take one full day in a venue and date that will be arranged by the GAAL.


- The Service provider will also be required to conduct/facilitate consultative sessions on the development of the new strategy.
- The Service provider will be required to facilitate the Board Strategic Planning session which will also take two full days.
- The services provider is expected to deliver the Strategic Planning Report in 3 weeks after the session.
- 2.2 In this regard, the service provider will be expected to work with the Office of the CEO in the facilitation of the Strategic Planning sessions and is expected to write and deliver the Draft Strategic Plan, the Draft Annual Performance Plan, and the Project Close-out report and these shall be developed in line with the Framework for Strategic Planning and Annual Performance Plan, as pronounced by the Shareholders' Department of Planning Monitoring and Evaluation (DPME).

3. DELIVERY TIMEFRAMES

The services provider is expected to deliver the Strategic Planning Report in 3 weeks after the session.

4. EVALUATION CRITERIA

All quotations will be evaluated in terms of administrative requirements and preference point system.



4.1 Gate 0: Administrative (mandatory) requirements

Supplier (s) must submit the documents listed in Table 1 below. All documents must be completed and signed in black ink by the duly authorised representative of the prospective bidder(s). Correction fluid is not allowed and any cancellation on the bid document must be initialled by the authorized signatory. During this phase, Bidders' responses will be evaluated based on compliance with the listed administration and mandatory bid requirements. The bidder(s) quotation will be disqualified for non-submission of any of the documents.



- 1.1 The following preference point systems are applicable to invitations to tender:
 - the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the 80/20 preference point system.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:
 - (a) Price; and
 - (b) Specific Goals.

1.4 To be completed by the organ of state:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender will be



interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. **POINTS AWARDED FOR PRICE**

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be
