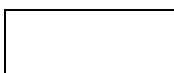
A compulsory tender briefing will be held on the 5th December 2022 at 10:00am at the municipal shelter at Kwaggafontein C, Mpumalanga.

The tenders and relevant documents must be sealed in an envelope and externally endorsed with **"APPOINTMENT OF A PANEL OF CONSULTING ENGINEERING FIRMS FOR THE IMPLEMENTATION OF INFRASTRUCTURE PROJECTS FOR THEMBISILE HANI LOCAL MUNICIPALITY, ON AN AS AND WHEN REQUIRED BASIS FOR THREE (3) YEARS"** and must be placed in the bid box at the Municipality office in Kwaggafontein no later than **12h00pm on the 15th December 2022**. Bids will be opened in public at the Municipal offices. **The Tenders shall remain valid for a period of 120 days from the closing date.** Telegraphic, telephonic, fax, telex e-mail or late tenders will not be accepted.

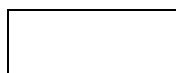
