INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by excelling in the management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

BUSINESS UNIT RESPONSIBLE FOR THE BID

SANParks wishes to procure the services of a partner to supply, support and maintain a Comprehensive Cybersecurity Awareness Training Program solution and associate cyber security awareness services for 4000 users for five (5) years to enhance the cyber security posture.

CONTEXT OF THIS PROCUREMENT

The purpose of the cyber security awareness programme is to enhance the cyber security knowledge and skills of our employees, ensuring they gain an understanding of cyber threats, vulnerabilities and how to protect SANParks information assets.

CONTRACT PERIOD

The contract will be for a period of **five (05) years**.

SPECIFICATIONS/SCOPE OF WORK

1. The solution must be fully customisable with the branding of SANParks
2. Must have a wide selection of easily customisable real-world Configurable Scenarios and scalable simulations based on the most common threats.
3. Must provide content of various types of content, videos, quizzes, etc.
4. Must have the capability to schedule training modules.
5. Scenarios must be packaged with templates for email messages, landing pages and learning material.
6. Must allow for conducting phishing simulations.
7. Analytics and Reporting
 - a. Visualise campaign results and determine the percentage of users who reported, opened simulation email, viewed images, clicked links, opened attachments and more.
 - b. Generate predefined reports with detailed data on simulation results, repeat clickers, and simulation comparisons.
