INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver the Conservation Mandate by Excelling in the Management of a National Park System

BUSINESS UNIT RESPONSIBLE FOR THE BID

This BID will be led by the Camdeboo National Park Management team. Camdeboo National Park is managed by South African National Parks. The Park is located around the town of Graaff Reinet in the Eastern Cape Province in the Republic of South Africa.

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a proposal for the appointment of a service provider to supply and deliver building suppliers for infrastructure maintenance at Camdeboo National Park for a period of five (5) years.

CONTRACT PERIOD

The contract will be for a period of **60 months (5 years)**.

SPECIFICATIONS/SCOPE OF WORK

SANParks seeks to appoint a reputable service provider that has the capability of supplying building supplies to Camdeboo National Park.

The required services will be contracted for a period of sixty (60) months.

DELIVERABLES

- SANParks reserve the right to Collect (pick up) the materials from the supplier's premises or any other agreed-upon location, should the materials be ready and delivery is not required.
- Quantities required per delivery shall be confirmed by a purchase order and delivery should be within 7 days from the date of issue of the purchase order.
- **Unit prices should include delivery costs** to Camdeboo National Park, N9 Middleburg road, Graaff Reinet, 6280.
- All items must be of good quality and must comply with the SABS standards. All electrical and other items must be SABS approved.

RESPONSIBILITIES OF SANPARKS

- To provide the tendering company with information that will assist in submitting the tender.
- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behavior will be prevented for future occurrences.
