2. SCOPE OF WORK

2.1 Background

The **National Radioactive Waste Disposal Institute (NRWDI)** is currently undertaking the transition and integration of the Vaalputs Disposal Facility with the Midrand Head Office network infrastructure. This initiative forms part of the organisation’s programme to modernise and consolidate the Administration and Operations environments into a single, secure, and compliant hybrid Active Directory and Microsoft 365 platform spanning:

- **Midrand Head Office** (Administration Services)
- **Vaalputs Disposal Facility** (Operational Services)

The Vaalputs end-user environment has already been standardised using Microsoft cloud productivity and security technologies, including:

- Microsoft 365 productivity apps (Word, Excel, PowerPoint, Outlook, OneNote, Access)
- Microsoft Teams (chat, voice, video conferencing)
- Exchange Online (email, calendar, archiving)
- SharePoint Online & OneDrive storage
- Microsoft Entra ID P1 (Hybrid Identity)
- Microsoft Intune (Device Management)
- BitLocker endpoint encryption
- Microsoft Defender for Endpoint Plan 1
- Microsoft Purview compliance features

- Windows 11 Enterprise upgrade

Following the acquisition of NIL43 licensing and the transfer of Vaalputs facility operations to NRWDI, the organisation must now upgrade its Microsoft 365 Business/Standard subscriptions to Microsoft 365 Enterprise E5.

This upgrade is required to ensure compliance with:

- Information State Security Act
- Protection of Personal Information Act (POPIA), Act 4 of 2013
- Critical National Infrastructure cybersecurity obligations

1. Evaluation Criteria

The evaluation will be carried out in three Phases:

- Phase 1: Mandatory Requirements (At Closing Stage)
- Phase2: Price and Specific Goals
- Phase 3: Mandatory Requirements (At Award Stage)

1.1 Mandatory Requirement (At RFQ Closing Date)

- A service provider who fails to quote fully or according to the price structure/table and scope of work will be disqualified.
- Quotation submitted after the closing date and time will not be considered for evaluation.
- Quotations that are not sent through the procurement central email will not be considered for evaluation.
- Submit a minimum of two reference letters from previous clients where Microsoft Subscription Licences were provided. The letters must be under the letterhead of the client, have contact details, be signed and must not be linked or conflicted to the Bidder.
- Submit a valid copy of a Certified Microsoft Partner.
- Service providers must be able to pay Microsoft first and provide proof of payment to

NRWDI before payment can be made or provide credible assurance (such contract/accounts arrangement with Microsoft) that Microsoft will be paid and the service to NRWDI will not be affected/stopped because of non-payment to Microsoft.

Failure to comply to the above mandatory requirements will disqualify your quotation.

- 3.4 The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.
- 3.6 I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA).

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“black people”** is a generic term which means Africans, Coloureds and Indians—
- a) who are citizens of the Republic of South Africa by birth or descent; or
 - b) who became citizens of the Republic of South Africa by naturalisation—
 - i) before 27 April 1994; or
 - ii) on or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalisation prior to that date;
- (b) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (c) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (d) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (e) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (f) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and
- (g) **“women”** means a person of female gender who is a citizen of the Republic of South Africa.

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
