1. BACKGROUND

Sekhukhune District Municipality (SDM) is both a Water Services Authority and Water Services Provider (WSP) in other areas of its operations. The Municipality has an obligation to provide a sustainable and uninterrupted water supply for the consumers within its area of jurisdiction. The Operation and Maintenance (O&M) is a division within the Department of Infrastructure and Water Services (IWS) that plays an important role in ensuring the sustainability of the water infrastructure assets for the provisioning of dignified basic water supply as mandated by the Constitution. The division is obliged to operate and maintain several Water Services Infrastructures including but not limited to the following: -

- Water Treatment Works
- Boreholes
