1. PURPOSE

the purpose of this exercise is to appoint a reputable contractor for the supply and installation of a 4-car shade port at the Scientific Services office, Rondevlei section of the Garden Route National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SPECIFCATIONS

Supply and Install 2 x Coupled Double Carports for 4 Car Parking with drop sides in the front and sides of the structure and roof consisting of shade net material.

Size 1: 5500mm x 5500mm + **Size 2**: 5500mm x 5500mm with 6 (101mm) fixed galvanised uprights which will need concrete foundation as there is no existing base to mount to.

Supply and Install 4 x Fix Side Panels

Side Panel Size: 4 x 5500mm x 2000mm

Colour of shade net: Forest Green

Material: Knitted from a mixture of high-density polyethylene monofilaments and monotype. UV stabilized and impervious to water and known chemical substances with a tested lifespan of 5 to 10 years. 90% shadecloth. C20/25 strength concrete with baseplate. 500mm x 500mm concrete blocks for poles. Poles to be concreted in at minimum 500mm and maximum 600mm

Structure: Pyramid shape: 48 x 2mm wall thick, hot dipped galvanized, low maintenance steel structure.

4. SPECIAL CONDITIONS

- Proof of experience in installing shade ports must be attached to this bid, with at least three references
- Successful bidder will be required to provide 10 years guarantee of the shade net material and 3 years warranty on workmanship

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

12. FINAL AWARD

Bidder who complies with the specifications and scores highest total points on PRICE and B-BBEE claimed points shall be awarded the contract. SANParks reserves the right to:

- Award the contract in full or partially
- Award to more than one bidder, and/or
- Not to award
- Re-advertise should the minimum of three written quotations not be received
- Not to award to the bidder scoring the highest points
- Not to award to bidders who have previously failed to deliver/ provided poor work.

2. **DEFINITIONS**
