NHC SEEKS TO INVITE QUOTATIONS FOR THE APPOINTMENT OF A SERVICE PROVIDER TO SUPPLY, DELIVERY AND FITMENT OF BLINDS.

INTRODUCTION

National Heritage Council of South Africa (NHC) is a Schedule 3(A) Public Entity that is responsible for the preservation of the country's heritage. The important areas that the NHC focuses on is policy development for the sector to meet its transformation goals, public awareness and education, knowledge production in heritage subjects that were previously neglected, and making funding available to projects that place heritage as a socio-economic resource.

Background

National Heritage Council are located at 353 Festival Street, Hatfield, Pretoria. The blinds are required to block the sun in such a way that adequate light is available in the offices.
