SCOPE OF WORK

- a. Supply and lease a fleet of vehicles and plant as specified in Annexure A.
- b. Provide full maintenance and repair services throughout the lease period.
- c. Implement a system for tracking devices and reporting fuel usage.
- d. All manufacturer warranties should be included.
- e. The finance lease (operating lease) with an option for vehicle and plant ownership transfer.
- f. The vehicles and plat shall be supplied fully licensed with fitted registration number plates and all permits where applicable.
- g. The vehicles and plant must comply in all respects with the Road Traffic Act, 29 of 1989.
- h. The vehicles and plant shall be supplied with a guaranteed heavy-duty battery of ample capacity
- i. The appropriate driver's manual, parts manual, and service manual are to be supplied with the vehicles
- j. Full training and instructions shall be provided to ensure the correct operating and proper maintenance of equipment and vehicles
- k. All vehicles and plant must be branded with Municipal logo per applicable departments
- l. Items are to be priced individually as per pricing table below and the sections must be fully completed in order for the bid to be evaluated for those sections
- m. Any additional features specified on the specifications shall not be quoted as extras, they must be included in the bid price.
- n. The prices quoted will be valid for duration of contract
- o. The municipality reserves the right to increase or decrease the quantity as and when need arises.

3. GENERAL

5. ADDITIONAL CONDITIONS

- 5.1. Delivery of all listed vehicles and plant within 60 -90 days of contract signing

- 5.5. Alert the municipality to abnormal fuel consumption

- 5.10. The bidder will be required to provide and manage services and facilities related to the ad-hoc rental of specific vehicles. The bidder will be responsible for insurance during ad-hoc rental.
- 5.11. Municipality reserves the right, at its discretion to request the successful bidder to install tracking devices on municipal own vehicles and plant should need arise.
- 5.12. The municipality shall have full access to tracking data for monitoring, security and operational purposes.
- 5.13. Ownership transfer
- At the end of lease term, the municipality shall have an option to acquire ownership of the leased vehicles and plant. This intension must be clearly indicated in the bidder's proposal.
 - The transfer of ownership shall be subject to a separate settlement agreement to be negotiated and concluded between the municipality and successful bidder.
 - The terms shall be fair, reasonable and based on the residual value taking into consideration depreciation, market value and condition of vehicles and plant at the time of transfer.
 - The bidder must indicate willingness to enter into agreement and facilitate the transfer of ownership to the municipality in the proposal and service level agreement.

6. TIMEFRAME

- 6.1. The duration of the project and contract with the successful service provider will be for the period of 36 months.
- 6.2. The project will commence in 2025/26 financial year, upon the date of signing of the Service Level Agreement (SLA) between the Municipality and the service provider.

7. PERFORMANCE MEASUREMENT/ REPORTING

- 7.1. The successful service provider will be required to provide monthly reports and progress will be monitored according to the agreed schedule and details contained in the project plan.

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.

However, the provider shall continue performance of the contract to the extent not terminated.</p> <p>24.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.</p> <p>24.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.</p>
25. Anti-dumping and countervailing duties and rights	<p>25.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. 30. Governing language	30.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
31. Applicable law	31.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.
32. Notices	<p>32.1 Every written acceptance of a bid shall be posted to the provider concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.</p> <p>32.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.</p>
33. Taxes and duties	<p>33.1 A foreign provider shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.</p> <p>33.2 A local provider shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.</p> <p>33.3 No contract shall be concluded with any bidder whose tax matters are not in order. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
