- 4 Tenderers are requested to furnish the full registered name of the tendering company/supplier on the Form of Quotation and Form of Acceptance, Form B.

SPECIFICATION

Objective

The main objective of this project is to appoint a SANAS (South African national accredited system) accredited Service Provider to calibrate the City's Air Quality Monitoring analysers in the city's monitoring network and the installation, connection, setup of rain gauge sensor to the ENVIDAS data logger.

2 Background

The City of Johannesburg is currently operating, maintaining and managing Air Quality-monitoring stations City wide.

The City, informed by the Air Quality Management Plan (AQMP,2019) and the state of the air in Johannesburg, has established this network to measure priority pollutants to use the information to develop and establish air quality reduction measures and strategies. The veracity of information from the air quality monitoring network plays a key role in making informed decisions about the measures required to protect the health & safety of living entities and protection of the environment itself as outlined in South African national legislation and the national framework concerning air quality.

To ensure that air quality data monitored in the city is complete, valid, and scientifically reliable, the South African National Accreditation System (SANAS) has put up systems and requirements aimed at guiding institutions in producing this information in a competent manner. These external annual calibrations are mandatory to the city and required when conducting continuous ambient air quality monitoring and are done to ensure that the information from the air quality network is valid and scientifically reliable as per SANAS requirements.

3. Scope of Work Required

Calibrate all gas analysers, particulate monitors and meteorological instruments as listed on table 1 and table 2. Calibrations to be conducted by a SANAS accredited institution in accordance with SANAS (South African national accredited system) accredited reference standards and methods and the recognized International Standard ISO/IEC 17025:2005.
