This specification calls for the following:

a) Supply, delivery, install and commission a 50kVA dry type transformer

#### 2. Scope of Work

2.1. Supply, delivery, install and commission a 50kVA dry type transformer to Nagle Dam Transformer Specification:

- 2.2 The contractor is to decommission the existing transformer and remove off-site which is to be stored at the Electrical Workshop, 13 Pineside Road, New Germany. The New transformer is to be rigged into place, installed, and commissioned.
- 2.3 The contractor is to provide the necessary termination kits, lugs, jointing kits, cables etc if required and as per the approval of the Project Manager.
- 2.4 The contractor to issue an Electrical Certificate of Compliance (COC) for the installation.

#### 3. Testing and Commissioning Programme

- 3.1 The contractor to provide all necessary documentation (datasheets, etc.) with regards to the transformer.
- 3.2 It is the contractor's responsibility to ensure that all equipment supplied is SABS
