1. TERMS OF REFERENCE

1.1. INTRODUCTION AND BACKGROUND

1.1.1. SASSETA was established on 1 July 2005. It is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31st March 2030. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.

1.2. PURPOSE

- 1.2.1. The purpose of this RFQ is to appoint a service provider to:
 - 1.2.1.1. facilitate the induction of the newly appointed Board members into the Sector Education and Training Authority environment on 13th and 14th November 2025.
 - 1.2.1.2. facilitate presentation and engagement by DHET & SETA management of the SETA Governance Framework, SETA performance, Current state of the SETA and approved 2018/19 Sector Skills Plan, Strategic Plan and Annual Performance Plan.

1.3. OBJECTIVES

- 1.3.1. The objectives of the project are;
 - 1.3.1.1. To provide the Board with information that will enable them to execute their fiduciary responsibilities as an oversight body in the SETA.
 - 1.3.1.2. To share valuable information about the legislative framework governing the SETAs.
 - 1.3.1.3. Ensure management engages and are fully aware of the approved Planning documents so that these are institutionalized and collectively owned

1.4. SCOPE OF WORK

- 1.4.1. The service provider will be required to undertake the following:
 - 1.4.1.1. Preside and direct a two day session wherein SETA management will lead presentations aimed at sharing relevant information with the Board to help them understand the legislative frame work governing the SETAs, the constitution specific to the SETA that informs the role of the Board and its committees as well as SETA planning framework to enable them to exercise oversight responsibility over management.
 - 1.4.1.2. Present the legislative framework, the Board oversight role and how they should be structured in order to fulfil their mandate. They'll further share some experiences on why some SETAs fail while others succeed to fulfil their role in the higher education and training value chain including factors leading to SETAs being put under Administration.
