1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method

envisaged in legislation;

- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

### BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

### Scope of Work:

**Iziko Museums of South Africa hereby invites suitably qualified and experienced service providers to supply and install an automatic toughened safety glass sliding door at one of its facilities. The door must include a manual operation option for use in the event of emergencies or power failures.**

The appointed service provider will be required to:

- Provide a **comprehensive sketch or technical diagram** of the proposed door system, clearly indicating dimensions, materials to be used, mechanism specifications, and method of operation.
  - Supply and install an **automatic toughened safety glass sliding door**.
  - Ensure the door has a **manual override function** to allow for operation during power outages or emergencies.
  - **Remove the existing glass pane** to make space for the new sliding door installation.
  - **Remove and replace broken glass pane** with the glass pane mentioned above -  
If not possible provide a new glass pane to replace broken glass pane.
  - **Replace broken glass pane** on the **5<sup>th</sup> floor**.
  - Provide **rope access** contractor to **clean glass pane**
  - **All broken glass** must be disposed by service provider.

## 2. EVALUATION CRITERIA

Iziko promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

Iziko is committed to achieving the Government’s transformation objectives in terms of the Preferential Procurement Policy Framework Act.

- Firstly, the bidder will have to comply with eligibility criteria as per Table 1
- Thereafter assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of **70** points. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Proposals will be evaluated on the 80/20 preference points scoring system: that is, 80% of the points awarded will be based on price, as indicated in the table below; and 20% of the points awarded will be based on specific goals, allocated as indicated in the table below:
