DESCRIPTION: SECURITY SERVICES AT PetroSA DEPOTS IN BLOEMFONTEIN AND TZANEEN

Registered and approved Suppliers (“Suppliers”) are hereby invited to submit a Tender for the provision of the above to PetroSA.

Tenders must be **submitted electronically via the E Procurement Portal** by logging on to the procurement website www.procurement.petrosa.com and selecting the ‘Login to Access Tenders/Quotes tab’ and logging on to the E Procurement Portal.

The Services to be provided shall be the following: -

1. Un-armed guarding and patrolling security service at the PetroSA Bloemfontein and Tzaneen Depots. The address for Bloemfontein Depot is: 2 Mill Street, Hamilton Industrial Site, Bloemfontein. The address for Tzaneen is Kudu Street, Industrial Site, Mopani District Municipality, Limpopo Province.
2. The Services include, but are not necessarily limited to, supervision, guarding duties, administrative duties, access control, loss control, investigations, emergency response, control room duties, permit office duties, screening for

substance abuse, ad hoc services and any other security related duties required by PetroSA.

3. The Supplier must be registered as a Security Service Provider, **prior to the commencement** of the contract.
4. The Supplier shall perform the Services on the following basis:
 - A 24-hour shift cycle coverage (24hr 7 days per week).
